### PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability offunds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

How will the LEA determine the most important educational needs as a result of COVID-19?

The District has established a Covid-19 leadership response team that includes administrators, teachers, parents, and local health officials. These team members will conduct a needs assessment as it relates to academics, health and safety, facilities, transportation, Child Nutrition, and school governance. These needs shall be prioritized to include a timeline for meeting those needs.

How does the LEA intend to assess and address student learning gaps resulting fromthe disruption in educational services?

The District plans to aggressively approach the learning gaps by reteaching critical skills that were covered after the schools closed in March. The district is also planning to employ retired teachers to provide small group and individual instruction during the day to students needs extra assistance. Additional tutorial services shall be provided to at-risk students in after school programming.

What is the LEA's proposed timeline for providing services and assistance to students and staff? Services begin upon approval of the application. The services will continue through Sept. 2022.

How will the LEA use ESSER funds to promote remote learning?

The District plans to employ 8 remote learning teachers to deliver instruction to students in grades K-8 that choose 100% e-learning. The District will use the Schools PLP curriculum provided by the ALSDE, and the Schoology platform. The District is planning to contract with Schools PLP to purchase an additional prescription for grades 9-12 for times when blended learning may become necessary for both students in 9-12 and for the Career Tech program.

4. Other Assurances and Certifications

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
