**PROGRAMMATIC, FISCAL AND REPORTING ASSURANCES**

After our own needs assessments our district determined the following as most important needs: air purifiers, chromebooks, software for remote learning filtering, nurse supplies, maintenance supplies, interventionist, indirect cost, and an intercom system to maintain the operation of and continuity of services in the school and very important for planning, coordinating, and general communication in the COVID 19 pandemic.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Attalla City Schools will begin immediately upon receiving funds to implement instructional support, remediation intervention, devices, provide needed support for students and staff for two years. These funds will provide support for school years 2020-2021 and 2021-2022. The district will also public bid the iWave-C Self Cleaning Air Purifiers to minimize the spread of COVID-19.

Attalla City Schools will use ESSER funds to promote remote learning through:  
-Parental Involvement/Education  
-Promotion of positivity to create climate conducive to growth and learning  
-Stakeholder involvement to give everyone a voice including parents, teachers, students, and community members  
-Removing all barriers to close the gap for regressions and deficiencies for all students as a result of COVID-19  
-Implement GoGuardian Suite to promote remote learning by content filtering on and off premise, promotes safety and security by monitoring student communication and files, fleet management by tracking device location, assignment, and repairs, and promote student engagement by allowing teachers to view student device screens.

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. 
