**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

**How will the LEA determine the most important educational needs as a result of COVID-19?**

Oneonta City Schools has conducted several surveys in regards to the events of the past three months. These surveys have allowed stakeholders to share their concerns with this past spring's distance learning plan and implementation as well as their expectations moving forward into the 2020-21 school year. Results of the surveys show that parents are concerned about keeping their children safe and healthy, both physically and mentally, when they return to school. They also want to ensure that students have all the tools necessary to be successful in distance learning. The results of the surveys, as well as local and state guidance, will help construct the plan that determines the needs of our local district.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

Upon return to school in the fall, each school will assess current student needs and develop a plan to address learning gaps. These plans could include remediation during the school day, intervention, and/or before and after school tutoring.

Beginning in July of 2020, we will begin providing summer services to qualifying students, and in August of 2020 services will begin with all students and staff. All qualifying expenditures will be made by September 30, 2022.

OCS will work to provide internet availability, school-issued devices, and paper packets to meet the needs of all students through participation in remote learning upon reopening school for the 2020-21 school year.

**4. Other Assurances and Certifications**

  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.


