## <u>MEMORANDUM</u>

**TO:** City and County Superintendents of Education

**RE:** Charter School Conversion Procedures

In accordance with the <u>Alabama School Choice and Student Opportunity Act 2023-420, as amended</u>, allows conversion charter schools to be established in Alabama in accordance with the law. The procedures for converting a non-charter school are outlined below:

## Procedures for Converting a Non-Charter Public School into a Conversion Charter School

- 1. The local school board should already be approved or <u>apply to become a charter school</u> <u>authorizer</u> with the Alabama State Department of Education (ALSDE).
- 2. Once approved, the local school board authorizer should participate in the required annual training approved by the ALSDE. The <u>Charter School Authorizers Annual Trainings memo</u> contains information regarding the training opportunities.
- 3. The non-charter school or part of the school to be converted should be identified using the following information completed by the local school board authorizer:
  - Community Engagement—Stakeholder Interest—Formation of Governing Board
  - Academic Performance Analysis
  - Financial Performance Analysis
  - Operational Performance Analysis
- 4. The local school board authorizer should have a plan described in the request for proposal/application to be released by November 1.
- 5. The application can be completed by community stakeholders, the proposed governing board, and/or an approved charter operator.

**Governing Board**—An independent board of a proposed conversion charter school that will contract with the authorizer. Membership must have 20% of parents of students who will attend or have attended the non-charter school for one year. Other possible board members should include community members with expertise in education, finance, law, etc. A local school board authorizer may also be selected to be on the conversion charter school's governing board.

**Charter Operator**—An entity with which a local school board authorizer has awarded a performance contract to oversee the implementation of any conversion charter school.

- 6. The proposed governing board should apply for 501(c)(3) status if the board does not currently have this status.
- 7. The proposed governing board, the community stakeholders, and/or the charter operator should complete a charter school application describing the academic, financial, and operational plan for the school and submit it to the local education agency authorizer.
- 8. The local school board authorizer or contracted charter operator must release a request for proposal allowing education service providers an opportunity to apply for the selected non-charter school to be converted. If a qualified Education Service Provider applies and is approved using a rubric approved by the ALSDE, a performance contract is negotiated with the selected Education Service Provider.
  - **Education Service Provider**—An entity with which a public charter school, local board authorizer, or contracted charter operator intends to contract for educational design, implementation, or comprehensive management.
- The submitted applications for the selected non-charter school to be converted will be reviewed and evaluated by the local school board authorizer using a process and rubric approved by the ALSDE.
- 10. The local school board authorizer will contract with the Education Service Provider after an evaluation and review of submitted proposals using a rubric developed by the ALSDE.
- 11. After five years, if a local school board authorizer chooses not to reapply for charter authority or its authorizer application is denied, any conversion charter schools will begin a transition period to revert to non-charter public schools.
