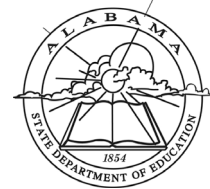

MEMORANDUM

TO: City and County Superintendents

RE: Supplemental Appropriations (Act 2025-268)

In accordance with Act 2025-268 and memo FY25-3039, the following information pertains to the supplemental appropriation for School Safety. These funds should be used to strengthen the security of school facilities, school buses, and school grounds. To facilitate the appropriate use of the Supplemental Allocation of School Safety funds, school systems should refrain from using these funds for personnel expenditures. We recommend utilizing these funds for the following purposes, including criteria related to the *School Security Act* in the *Code of Alabama* Title 16-22B (1975):

- Access Control Systems
- Alarm Systems
- Breaching Tools
- Bullet Resistant Film
- Curriculum for Required Annual Trainings
- Emergency Escapes
- Emergency Kits / AED Systems
- Emergency Notification Systems
- Fencing
- Fire Extinguishers
- Intrusion Detection
- Intercom Systems/Communication Equipment
- Knox Key Box
- Locks on exterior and interior doors
- Panic Buttons
- Portable Weapon Detection System/Metal Detectors
- Security Cameras
- Software Security Applications
- Upgrade / New Surveillance Systems
- Visitor Management Systems
- Walkie Talkie Radio Systems
- Windows

The allocation for each school system is attached. These funds should be recorded in fund source 1770. Expenditures related to these funds should be coded using Appropriation Year 1 and be spent by September 30, 2026. The funds will be automatically disbursed.
