APPROVED ORGANIZATIONS RECEIVE FEDERAL REIMBURSEMENT FOR PROVIDING MEALS AND SNACKS

Montgomery, **Ala.** - The Alabama State Department of Education is seeking schools and fiscally responsible community organizations to serve as sponsors of the Summer Nutrition (SUN) Programs in 2026.

SUN meals sponsors help ensure children who have limited access to food at home get nutritious meals needed for optimal growth, development, and overall well-being when school is not in session.

Many children rely on the nutritious meals and snacks served during the school year through the National School Breakfast and National School Lunch Programs. Alabama's SUN Programs help fill in the gap by providing free meals and snacks to eligible children, ages 18 and younger who might otherwise go hungry during the summer months.

The Summer Food Service Program is administered by the Alabama Department of Education Child Nutrition Programs and federally funded through the U.S. Department of Agriculture (USDA). Last summer, SFSP sponsors served over 2.5 million meals to hungry children across the state.

Organizations eligible to serve as sponsors are:

- public or private school food authorities,
- private non-profit organizations,
- government entities,
- faith-based organizations and
- camps

Eligibility requirements for a private nonprofit organization to become a sponsor include, but not limited to the following:

- 1) maintaining tax exempt status with the IRS
- 2) operating year-round service to the community in which summer meal sites will be located, and
- 3) providing documents to support the financial solvency of the organization.

Of particular need are organizations in rural areas where access to summer meal sites or transportation creates a deterrent to program participation. New federal regulations permit sponsors with a rural designation to apply for approval to provide multi-day meal kits to be taken away from the meal site for children to enjoy throughout the week.

SPONSORS AND THE SUMMER NUTRITION (SUN) PROGRAMS IN 2026

Returning sponsors and prospective new sponsors are required to attend annual training. Training sessions are scheduled throughout the state during the month of February 2026.
