**MEMORANDUM**

**RE:** Fiscal Year (FY) 2021 Allocations for Summer Reading Camps

The Alabama State Department of Education (ALSDE) is committed to providing support for Summer Reading Camps to benefit all K-3 students identified with a reading deficiency. The *Alabama Literacy Act* (ALA) describes two programs as follows:

A. Alabama Summer Achievement Program (ASAP)

As stated in the ALA, the ASAP will be available to all K-3 students in public elementary schools that are among the lowest performing five percent of elementary schools. Funds appropriated by the Legislature in support of the Alabama Reading Initiative have been allocated to support and fund the ASAP. Each school will receive a base amount, plus teacher salaries based on the number of students with a deficiency as reported in the September 30, 2020, reporting document in Caveon.

B. Summer Reading Camps

Each local education agency shall provide summer reading camps to all K-3 students identified with a reading deficiency. Funds appropriated by the Legislature in excess of the amount needed to fully fund ASAP shall be divided, based on a per-pupil allocation, and distributed by the State Superintendent of Education, to support high-quality summer camps at schools that are not among the lowest five percent performing schools. Each school system will receive funds based on the number of students with a deficiency as reported in the September 30, 2020, reporting document. Individual school amounts and requirements will be provided in a follow-up email to superintendents and ARI contacts.

Attachment 1 shows the total allocation for ASAP (if applicable) and Summer Reading Camps for each school system.
