RESOLUTION TO AUTHORIZE REVIEW OF EDUCATOR PREPARATION PROGRAMS Jacksonville State University

WHEREAS, Alabama Administrative Code, Rule No. 290-3-3-.56(4)(b)2., requires that approval by the Alabama State Board of Education shall be secured before a proposal for new programs is reviewed by the Office of Teaching and Leading of the Alabama State Department of Education; and

WHEREAS, the State Superintendent of Education has received from the President of Jacksonville State University a written request to develop a Class B Computer Science (6-12) program and an innovative Class A Mathematics Specialist (K-5) program; and

WHEREAS, the request lists the specific proposed programs for which the Alabama State Board of Education authorization is being sought; and

WHEREAS, Jacksonville State University personnel have been advised that the proposed programs may not be implemented prior to Alabama State Board of Education approval, based on documentation of compliance with all applicable standards; and

WHEREAS, the State Superintendent of Education recommends that the programs be reviewed by the Office of Teaching and Leading of the Alabama State Department of Education:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education hereby authorizes a review of the following programs:

Class B Computer Science (6-12) Class A Mathematics Specialist (K-5)

RESOLUTION TO APPROVE AN EDUCATOR PREPARATION PROGRAM The University of Alabama (UA)

WHEREAS, Alabama Administrative Code, Rule No. 290-3-3-.56(4)(b)2., requires that approval by the Alabama State Board of Education shall be secured before a proposal for a new program is reviewed by the Office of Teaching and Leading of the Alabama State Department of Education; and

WHEREAS, the Alabama State Board of Education authorized a review of a proposed Class AA Library Media program to be provided by The University of Alabama; and

WHEREAS, a review of the proposed program determined that all applicable standards were met; and

WHEREAS, the State Superintendent of Education recommends that the program be approved:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education hereby approves the following program through June 30, 2024, the date when approval of all other University of Alabama educator preparation programs will expire:

EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Eric G. Mackey stated that there was no report necessary for the month of November.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey thanked his colleagues at Jacksonville State University (JSU) for promoting two very innovative programs. Dr. Mackey reminded the Board that they approved for a review of the beginning of authorizing possibly two new programs at JSU. Dr. Mackey informed the Board that after the review is completed, the programs will come back before the Board. Dr. Mackey stated that the new programs are Class B Computer Science, Grades 6-12, and Class A Mathematics Specialist, Grades K-5. Dr. Mackey stated that after the review is completed at JSU, this will be the first Computer Science degree program under the new rules that the Board adopted last year to allow the development of such programs at universities. Dr. Mackey expressed that he was very happy that JSU stepped out and decided to offer the new Computer Science specialty program. He stated that it will be an undergraduate Computer Science certification program.

Dr. Mackey stated that the other program the Board approved was a master's level Class A Mathematics Specialist, Grades K-5 program. Dr. Mackey stated that JSU asked for permission to develop a master's degree for elementary teachers that will have a Mathematics specialist degree. He said that this will be the first of its kind across the state. Dr. Mackey stated that JSU has thrown out two really good ideas and are kind of leading the way. Dr. Mackey stated that Alabama has good programs all over the state, but specifically focused on JSU because of its new creative and innovative leadership programs. Dr. Mackey stated that he is excited about both programs, but especially the Mathematics Specialist. Teachers who are interested in obtaining a master's degree in Elementary Education, with a focus on Mathematics leadership, can attend JSU. Dr. Mackey stated that the teachers can continue to be certified elementary teachers with a master's degree in Mathematics leadership for elementary grades.

Dr. Mackey informed the Board that the National Blue Ribbon Schools was announced last month. He said that Alabama's National Blue Ribbon Schools will not be recognized during the Board meeting today, because the National Blue Ribbon Schools are being honored by the U.S. Secretary of Education in Washington, D.C. Dr. Mackey stated that Alabama has five National Blue Ribbon Schools that will be honored by Alabama in December or January. The National Blue Ribbon Schools in Alabama are listed below:

Bob Jones High School, Madison City School System Alabama State Board of Education, District Eight

Cleburne County Elementary School, Cleburne County School System Alabama State Board of Education, District Two

Hewitt-Trussville High School, Trussville City School System Alabama State Board of Education, District Seven

John S. Jones Elementary School, Etowah County School System Alabama State Board of Education, District Eight

New Century Technology High School, Huntsville City School System Alabama State Board of Education, District Eight
