Some tests instruments for young children report scores in years and months. To be eligible for special education services in Alabama, a standard score with a mean of 100 and a standard deviation of 15 must be used and recorded on the eligibility report.

Example: If a child's chronological age is 4:8 (four years eight months) obtains a score at or below of 3:6 (three years six months), a score of 77SS and below would be assigned and recorded on the eligibility report. This is the same as reporting the child has a 25% delay. If the same child that is 4:8 (four years eight months) obtains a score at or below of 3:3 (three years three months), a score of 70SS and below would be assigned and recorded on the eligibility report. This is the same as reporting that the child has a 30% delay.
