## Purpose

■ In the current state of emergency for the COVID-19 pandemic, it is not feasible nor safe to conduct many of the state-required drills where students, faculty and staff would move throughout the schools at the same time and within close proximity to each other; therefore, an alternative method of compliance while maintaining as safe an environment as possible must be developed.

  - Alabama State Fire Marshal Regulation 482-2-102-.01c

- Lockdown Drills
  - Code of Alabama § 16-1-44(g)

Drills Available for Virtua

■ Tabletop/Workshop-style drills are

 Should not take the place of phy escape/sheltering routes at lear required trainings.

 After routes are walked, discuss encouraged

 Teachers - take advantage of the opportunity of the virtual learning environment by encouraging students to talk with their family members about emergency protective actions within their home or place of learning

#### Drills for In-Person Education

- Drills must be conducted within certain time constraints; however, they do not state they must be done all at once
- To minimize cross-contamination of classes/persons, fire and severe weather drills should be conducted over the course of a few days
  - Allows for each class, by themselves and while maintaining proper face coverings and social distancing, to walk their respective routes
  - Ensures students and teachers are familiar with the routes and expectations prior to a dangerous event

#### Severe Weather Drills

- Coordination with other classes and school administration must be done in advance to ensure timing and route/shelter locations are clear of others and can be cleaned if necessary
- Younger children (Pre-K through 5<sup>th</sup> Grade) should practice the appropriate protective position while properly spaced for social distancing precautions as to ensure children retain muscle memory actions
  - Protective position includes backs against the wall with a book or object covering their heads and necks
- Older students may be shown the appropriate protective position

#### Fire Drills

- Coordination with other classes and school administration must be done in advance to ensure timing, route & meeting destination locations are clear of obstructions and other people for social distancing requirements
- Coordinate with your local fire department to practice the interaction that will be necessary during a real-world event (i.e. accountability, access, FDC locations, etc.)

# Lockdown/Active Shooter/Intruder Drills

- Lockdown drills can still be conducted by each classroom while maintaining appropriate social distancing and face coverings.
- These drills are usually procedural and can be done while adhering to COVID-19 health guidance (i.e. locking a door, ensuring student accountability, discussing "what if" scenarios and perhaps movement to various locations within the classroom away from a door).

#### Other Best Practices

- Utilize local first responders in your drills
  - Coordination between school administration and first responders is critical
  - Universal safety precautions must be strictly adhered to by first responders and staff to limit possible exposures
- Ensure substitute teachers and other regular visitors are made aware of emergency plans in the event they must initiate protective actions
- Document all drills, briefings and discussions, whether virtual or in-person, and upload into nSIDE for credit
