# RESOLUTION FOR ADOPTION CAREER AND TECHNICAL EDUCATION STATE COURSE OF STUDY

## (Career Clusters: Business Management and Administration, Finance, Manufacturing, Marketing, Work-Based Learning)

WHEREAS, Title 16, Chapter 35, Section 3 of the *Code of Alabama*, 1975 requires the State Courses of Study Committee to prepare the contents of the courses of study for each grade of the elementary and secondary schools; and

WHEREAS, the report of its recommendations with respect to the compulsory minimum content of courses of study and of recommended revisions of courses, materials, subject content, and treatment in specific courses in such areas are required; and

**WHEREAS**, said law requires that the reports be submitted to the State Superintendent of Education and to members of the State Textbook Committee for separate written recommendations to the Alabama State Board of Education; and

**WHEREAS**, the State Superintendent of Education has reviewed the State Course of Study Committee's report on Career and Technical Education and recommends its adoption:

## RESOLUTION TO RECEIVE RECOMMENDATIONS OF THE STATE TEXTBOOK COMMITTEE FOR ADOPTION OF TEXTBOOKS FOR CAREER AND TECHNICAL EDUCATION CLUSTERS: AGRICULTURE, FOOD AND NATURAL RESOURCES; LAW, PUBLIC SAFETY, CORRECTIONS, AND SECURITY; SCIENCE, TECHNOLOGY, ENGINEERING, AND MATHEMATICS (STEM)

WHEREAS, the Alabama State Textbook Law provides that textbooks be adopted by the Alabama State Board of Education according to a rotation cycle, and this is the year for Career and Technical Education clusters: Agriculture, Food and Natural Resources; Law, Public Safety, Corrections, and Security; Science, Technology, Engineering, and Mathematics (STEM); and

**WHEREAS,** said law also provides that the State Textbook Committee meet to review textbooks submitted by publishing companies and prepare recommendations for adoption and/or rejection for submission to the Alabama State Board of Education; and

**WHEREAS**, the 2020 State Textbook Committee has met and has prepared such recommendations:

**NOW, THEREFORE, BE IT RESOLVED,** That the attached recommendations for adoption of textbooks made by the State Textbook Committee are hereby received by the Alabama State Board of Education and such recommendations will be considered for approval on May 13, 2021.

#### RESOLUTION IN RESPONSE TO COMPONENTS OF THE ALABAMA LITERACY ACT REGARDING EDUCATOR ASSESSMENT REQUIREMENTS

**WHEREAS,** the Alabama Literacy Act, enacted June 10, 2019, and now codified as Section 16-6G-1, *et seq.*, Code of Alabama (1975) affirms Alabama's commitment to improving K-3 reading proficiency by establishing specific guidelines for the licensure and certification of Alabama educators; and

**WHEREAS**, a passing score on a foundational reading assessment is a precondition for initial certification, via the Alabama-approved Educator Preparation Program Approach, and other certification approaches, in the areas of elementary education (K-6), early childhood education (P-3), and collaborative special education (K-6); and

WHEREAS, Praxis #5205 Teaching Reading: Elementary, a foundational reading assessment administered by Educational Testing Service (ETS), is currently required for initial certification, via the Alabama-approved Educator Preparation Program Approach, and other certification approaches, in the areas of elementary education (K-6), early childhood education (P-3), and collaborative special education (K-6); and

WHEREAS, Foundations of Reading 90 is a Massachusetts foundational reading assessment administered by the Evaluation Systems Group of Pearson. An updated version, Foundations of Reading 190, will be available for use by other states on August 23, 2021; and

WHEREAS, the Alabama statewide pass rate for Praxis #5205 Teaching Reading: Elementary is 85% for the 2018-2019 scholastic year and 89% for the 2017-2018 scholastic year; and

**WHEREAS**, the Massachusetts statewide pass rate for *Foundations of Reading 90* is 63% for the 2018-2019 scholastic year and 64% for the 2017-2018 scholastic year; and

**WHEREAS**, a subcommittee of the Literacy Task Force established in Section 16-6G-3 of the *Alabama Literacy Act* has conducted a review of Praxis #5205 Teaching Reading: Elementary and *Foundations of Reading 190*; and

**WHEREAS**, the Alabama State Board of Education determines the Foundations of Reading 190 assessment is more closely aligned with the science of reading:

**NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education hereby confirms its intention to discontinue the use of Praxis #5205 Teaching Reading: Elementary for certification in the areas of elementary education (K-6), early childhood education (P-3), and collaborative special education (K-6), and adopts, as a replacement, *Foundations of Reading 190*; and

**BE IT FURTHER RESOLVED,** That for the areas of elementary education (K-6), early childhood education (P-3), and collaborative special education teacher (K-6), *Foundations of Reading 190* will now be utilized as:

- An initial certification precondition for individuals unconditionally admitted to an approved program at an Alabama Educator Preparation Provider (EPP) on September 1, 2022, and thereafter;
- A certification requirement for initial Alabama certification based upon all certification approaches other than the completion of an EPP for applications received in the Educator Certification Section of the Alabama State Department of Education (ALSDE) on September 1, 2022, and thereafter;
- A reinstatement requirement for a lapsed certificate for certification applications received in the Educator Certification Section of the ALSDE on September 1, 2022, and thereafter; and

**BE IT FURTHER RESOLVED,** That the Alabama State Superintendent of Education is hereby directed to take any and all actions necessary to implement this resolution.

### RESOLUTION IN RESPONSE TO COMPONENTS OF THE ALABAMA LITERACY ACT REGARDING SUMMER READING ASSESSMENTS

**WHEREAS,** the Alabama Literacy Act, enacted June 10, 2019, and now codified as Section 16-6G-1, *et seq.*, *Code of Alabama* (1975) affirms Alabama's commitment to improving K-3 reading proficiency; and

**WHEREAS,** pursuant to the Act, each local education agency shall provide summer reading camps to all K-3 students identified with a reading deficiency; and

**WHEREAS**, the Act also establishes the Alabama Summer Achievement Program for all K-3 students in public elementary schools that are among the lowest performing five percent of elementary schools; and

WHEREAS, pursuant to the Act, the Alabama State Superintendent of Education shall provide guidelines for the administration of the Alabama Summer Achievement Program and convene a standing task force (Alabama Literacy Task Force) to provide recommendations for comprehensive core reading and reading intervention programs, a state continuum of teacher development, and an annual list of vetted and approved assessments that are valid and reliable reading screening, formative, and diagnostic assessment systems for selection and use by local education agencies; and

WHEREAS, also pursuant to the Act, summer reading camps shall be staffed with highly effective teachers, shall provide direct, explicit, and systematic reading intervention services, shall include 70 hours of reading instruction and intervention, and shall include the administration of an Alabama State Board of Education approved reading assessment system at the beginning and end of the summer reading camp to measure student progress; and

**WHEREAS**, multiple early reading assessment systems were submitted for consideration by the Alabama State Department of Education and reviewed by the Alabama Literacy Task Force; and

**WHEREAS,** following said review, the Alabama State Superintendent of Education published the first annual vetted and approved early reading assessment list on or about March 11, 2020. Not only will schools be able to use these assessment systems for the identification of students at risk for math and literacy difficulties, including dyslexia, but the reading assessment systems may also assist schools in meeting annual screening and reporting requirements of the *Alabama Literacy Act*:

**NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education hereby adopts the Alabama State Superintendent of Education's annual vetted and approved early reading assessment list and those replacement lists that continue hereafter, as the Alabama State Board of Education approved reading assessment system to be used at the beginning and end of the summer reading camp to measure student progress; and

**BE IT FURTHER RESOLVED,** That the Alabama State Superintendent of Education is hereby directed to take any and all actions necessary to implement this resolution.

## SELECTION OF ALABAMA STATE BOARD OF EDUCATION MEMBER TO SERVE ON THE ALABAMA TEACHER OF THE YEAR COMMITTEE FOR STATE JUDGING

On motion by Mrs. Jackie Zeigler and seconded by Dr. Wayne Reynolds, the Board voted unanimously for Dr. Tonya Chestnut, State School Board District Five, to serve on the Alabama Teacher of the Year Committee as the State Board's representative.

# EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Eric G. Mackey stated that there was no report necessary for the month of March.

## STATE SUPERINTENDENT'S REPORT

Dr. Mackey thanked the English Language Arts (ELA) and Career and Technical Education (CTE) Committees that put together the Courses of Study. He said the committees took a lot of time and effort to do the difficult work. Dr. Mackey stated that it has been more challenging this year due to the COVID-19 pandemic. He said the committees began their work a year ago and was only able to meet in person once. Dr. Mackey stated that the committees consist of teachers, volunteers of parents, and business people in our communities across the state who volunteered their time to do the work. Dr. Mackey thanked Mrs. Catherine Jones, Mr. Sean Stevens, and many others who led the work of the committees. He also thanked Governor Ivey and the Board for adopting the ELA and CTE Courses of Study in order to help the department move forward with the work.

Dr. Mackey stated that a discussion of the textbook process will take place in April. He said that the Board can take some time during the Work Session to discuss the process as it goes forward.

Dr. Mackey gave a big thank you to the Arts group and Mr. Andy Meadows who single handedly coordinates the Arts for the state. Arts are also in Mr. Stevens' area. He said again, it has been a very difficult year. Dr. Mackey stated that Mr. Meadows tells him all the time that Arts are core. Arts are a core to life, core to civilization, core to history, and core to our future. Dr. Mackey decided to skip some of his speech because Summer Burress did a great job explaining Arts and the importance of Arts. Dr. Mackey stated that it has been so difficult to teach Art, but Alabama teachers have risen to the challenge and above making sure that their students are engaged. He said that many people have come to the visual arts and performing arts for comfort. He said congratulations again to Alice Keller and Summer Burress for winning the Elementary and Secondary Best of Show in the 2021 State Superintendent's Visual Arts Exhibitions. Dr. Mackey acknowledged that Mrs. Belinda McRae, Alabama State Board of Education Member, District Seven, is also an Arts person and director of the Northwest Alabama Arts Council.
