The Alabama State Board of Education met for its regular meeting of Elementary/Secondary Education matters on Thursday, April 8, 2021, at 10 a.m., in the auditorium of the Gordon Persons Building, Montgomery, Alabama. The meeting was called to order by the President of the Board in accordance with *Alabama Code* (1975), §16-3-7, as amended.

RESOLUTION TO MODIFY PASSING PRAXIS SCORE FOR THE AREA OF FAMILY AND CONSUMER SCIENCE AS A PRECONDITION FOR INITIAL CERTIFICATION

WHEREAS, by Resolutions of April 14, 2005; February 9, 2006; October 12, 2006; December 14, 2006; March 8, 2007; July 10, 2012; July 9, 2013; December 14, 2017; December 13, 2018; August 8, 2019; March 12, 2020, and other Resolutions from time to time, the Alabama State Board of Education has adopted certain Praxis subject assessments and minimum passing scores as conditions for initial educator certification in the state of Alabama; and

WHEREAS, earning a passing score on a Praxis subject assessment is a prerequisite for initial certification, via State-approved program and several other certification approaches in all subjects for which there is a Praxis subject assessment; and

WHEREAS, Educational Testing Service recommended a passing score of 153 for Praxis 5122 Family and Consumer Science based on the October 2013 Multistate Standard-Setting Study; and

WHEREAS, an additional Alabama Standard-Setting Study comprised of Alabama Family and Consumer Science Educators was performed in October 2013 and resulted in a suggested passing score of 161; and

WHEREAS, the Alabama State Board of Education approved a Resolution to adopt a passing score of 161 on Praxis 5122 Family and Consumer Science on March 12, 2014; and

WHEREAS, the current director of the Alabama State Department of Education, Office of Career and Technical Education, requests that the Alabama State Board of Education discontinue the current required score of 161 and adopt the Educational Testing Service recommended multistate passing score of 153; and

WHEREAS, Alabama uses the Educational Testing Service recommended multistate score on all currently required Praxis tests except Praxis 5122 Family and Consumer Science:

NOW, THEREFORE, BE IT RESOLVED, That effective the date of this Resolution, the Alabama State Board of Education hereby discontinues the current required score of 161 on Praxis 5122 Family and Consumer Science and adopts the Educational Testing Service recommended multistate passing score of 153; and

WHEREAS, UAH personnel have been advised that the proposed programs may not be implemented prior to Alabama State Board of Education approval based on documentation of compliance with all applicable standards; and

Dr. Eric G. Mackey stated that there was no report necessary for the month of April.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey thanked the Governor and Board for approving the promotion of Mrs. Angela Martin to Deputy State Superintendent of Division of Instruction and the hiring of Mrs. Shanthia Washington as Assistant State Superintendent of Evaluation, Accountability, and Support. He stated the two wonderful ladies are going to do excellent jobs. Dr. Mackey stated that the department is very sorry about losing Dr. Daniel Boyd. He said Dr. Boyd will mentor Mrs. Martin over the next two months. He stated that a couple of the Board members asked whether or not they will see him again. Dr. Mackey stated that Dr. Boyd will be given a proper celebration of his retirement at the right time. He said the department is fortunate to have good people that Dr. Boyd has worked with and mentored. Dr. Mackey stated that Wrs. Martin is the right person. He said there are many qualified people across the state and within the department, but Mrs. Martin will be able to step right in and execute a smooth transition. He said that even though times are difficult because of the pandemic, there is no doubt that Mrs. Martin can lead the Division of Instruction with integrity.

Dr. Mackey stated that many may remember Mrs. Shanthia Washington was in the department as an Assistant State Superintendent and retired when Dr. Ed Richardson served as Interim State Superintendent. He said that Mrs. Washington was brought back to do some interesting things at the department. She served as Interim Special Education Director for the department and is assisting the new Special Education Director. Dr. Mackey stated that the department is thrilled that Mrs. Washington was willing to come out of retirement.

Dr. Mackey recognized some educators that attended the Board Meeting. He thanked Mr. Dave Weis, Chairman of the Madison County Board of Education; Ms. Laterrius Christian, Counselor of A. H. Parker High School; Mrs. Kathy Dean, Counselor of Sulligent School; and Mrs. Priscilla Yother, retired principal of Eura Brown Elementary School, Gadsden City School System. Dr. Mackey said that Mrs. Yother has always wanted to attend a Board Meeting and was glad she was able to attend this one. He thanked Mrs. Yother for her service as a principal. Dr. Mackey stated that Mr. Sean Stevens spoke highly of Ms. Christian and Mrs. Dean. He said they both are outstanding counselors.

Dr. Mackey recognized Mrs. Dawn Morrison, Education Administrator, in the Career and Technical Education/Workforce Development Section. He commended Mrs. Morrison for her contributions to the department. He said she has been leading the Computer Science outstanding work for a number of years.

Dr. Mackey recognized Dr. DaLee Chambers, who is the new Special Education Director. Dr. Mackey stated that Dr. Chambers has been in the department for some time and recently assumed the role of director.

Finally, Dr. Mackey stated that the vast majority of Alabama students are back in the classrooms resuming in-person instruction.
