Dr. Eric G. Mackey stated that there was no report necessary for the month of July.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey stated that today is the Alabama State Board of Education's Annual meeting, which is the only meeting scheduled in the state constitution and occurs on the second Tuesday in July in order to elect the Vice President and President Pro Tem. He thanked the Board Members who made some arrangements to meet today to serve the Board's constitutional duties to elect officers.

Dr. Mackey noted that the MEGA Conference is going on this week in Mobile, Alabama. He stated that Mrs. Jackie Zeigler was able to join him yesterday to welcome 3,600 professional educators in person and approximately 1,000 virtual attendees. Dr. Mackey stated that approximately five percent of employees are gathered together at one place listening, learning, and getting high-quality professional development. He said it was a great kick off ceremony for the conference. Dr. Mackey stated that he shook a lot of hands and greeted hundreds of educators attending the MEGA Conference. He said it was good to see people back together learning in person.

Dr. Mackey gave a big thank you to everyone in the Alabama State Department of Education. Dr. Mackey stated that Mrs. Nora Thorington serves on the MEGA Committee and helps to coordinate the conference delayed her departure until after the Board's meeting. He said that it is a positive sign for the upcoming schools after witnessing lots of good discussions about classroom interventions and things that educators want to do. Dr. Mackey thanked all of the sponsors and supporters of the MEGA Conference. He said that he hopes that is a good sign of a positive school year to come.
