ALABAMA STATE BOARD OF EDUCATION RESOLUTION TO RELEASE MONTGOMERY COUNTY BOARD OF EDUCATION FROM EDUCATIONAL INTERVENTION

WHEREAS, the Alabama State Board of Education and the State Superintendent of Education are vested by the Alabama Constitution and the laws of the state of Alabama with authority to exercise general control and supervision over public schools of the state of Alabama; and

WHEREAS, local boards of education perform a state function at the local level and function as an arm of the state subject to the general supervision of the Alabama State Board of Education; and

WHEREAS, more particularly, the *Code of Alabama*, including the *Educational Accountability and Intervention Act of 2013* (the "Act"), codified at *ALA. CODE* §§16-6E-1 through 7, provides for intervention of local boards of education by the State Superintendent of Education under certain conditions; and

WHEREAS, at their February 7, 2017, board meeting, the Montgomery County Board of Education consented to educational intervention by the Alabama State Board of Education; and

WHEREAS, the Montgomery County Board of Education has been under educational intervention since 2017; and

WHEREAS, during this time of educational intervention, the Montgomery County Board of Education, Montgomery County Superintendent of Education Dr. Ann Roy Moore, and Montgomery Public Schools have collaborated and cooperated with the State Superintendent of Education in addressing and correcting deficiencies leading to educational intervention; and

WHEREAS, at the September 10, 2020, Alabama State Board of Education Work Session, officials from Montgomery Public Schools presented an update and progress of their intervention process; and

WHEREAS, the Montgomery County Board of Education has indeed achieved suitable and significant progress toward correcting those deficiencies that led to educational intervention; and

WHEREAS, the Montgomery County Board of Education has now met the criteria to be released from educational intervention; and

WHEREAS, on May 13, 2021, the Montgomery County Board of Education presented its petition to the Alabama State Board of Education to release Montgomery County Board of Education from educational intervention based upon the school system having met the criteria and conditions required for release; and

WHEREAS, the State Superintendent of Education has reviewed the petition for release from intervention, asserts his belief that the petition has merit, and recommends that the Alabama State Board of Education approve releasing the Montgomery County Board of Education from educational intervention:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education does approve and authorize releasing the Montgomery County Board of Education from educational intervention and that the Alabama State Board of Education strongly encourages the Montgomery County Board of Education and Montgomery Public Schools to maintain the fiscal and academic improvements implemented and achieved during their time of intervention in order to continue improvement as a system; and

BE IT FURTHER RESOLVED, That, pursuant to *ALA. CODE* §16-6E-4(9), the Alabama State Department of Education (ALSDE) shall release the Montgomery County Board of Education from educational intervention effective December 1, 2021, conditioned upon compliance with the following: maintain adequate academic progress; maintain fiscal sustainability by having a minimum of 1.5 months financial reserve; and maintain adequate operational standing in areas related to transportation, child nutrition, and other auxiliary departments. All conditions are subject to periodic review by the ALSDE.

ANNOUNCE INTENT TO REPEAL AND ADOPT NEW ALABAMA ADMINISTRATIVE CODE CHAPTER 290-3-3, PERTAINING TO EDUCATOR PREPARATION

On motion by Dr. Yvette Richardson and seconded by Mrs. Tracie West, the Board voted unanimously to adopt the following.

ADOPT AMENDED ALABAMA ADMINISTRATIVE CODE CHAPTER 290-3-1, PERTAINING TO PUBLIC SCHOOL GOVERNANCE

EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Eric G. Mackey stated that there was no report necessary for the month of June.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey stated that all agenda items were very important issues, including the Montgomery County School System's resolution to be released from educational intervention. Dr. Mackey commended the Alabama State Board of Education, Alabama State Department of Education staff, and particularly Dr. Daniel Boyd, Deputy State Superintendent of Instruction, and Mr. Terry Roller, Assistant State Superintendent of Support Services, who did an outstanding job with the Montgomery County School System to make sure goals were met. Dr. Mackey thanked Dr. Ann Roy Moore, Superintendent, Mr. Arthur Watts, Chief School Financial Officer, and many others at the Montgomery County School System for their leadership. Dr. Mackey acknowledged the Montgomery County School Board Members who ran for office because they believed in children and wanted to do what was right for the children. He thanked them for their commitment and hard work.

Dr. Mackey stated that the last item approved by the Board (Adopt Amended Alabama Administrative Code, Chapter 290-3-3, Pertaining to Public School Governance) is a change to address an issue about social security numbers. He said with that vote, all schools in Alabama will no longer collect social security numbers for student enrollment. Dr. Mackey said the department received numerous calls from concerned parents about data theft and the risk of their children's social security numbers being stolen. Dr. Mackey thanked the Board for supporting the effort to protect children's identity. He stated that collecting social security numbers for student enrollment has not been a practiced requirement for years, but some school systems were continuing to request the information and the vote today will completely remove the request from the Code.

Dr. Mackey reminded the Board that this will be Dr. Daniel Boyd's last Board Meeting due to his retirement at the end of June. Dr. Mackey stated that Dr. Jeffery Langham will be retiring the end of July. He stated that Drs. Boyd and Langham committed a lot to the Alabama State Department of Education and to local school systems. Dr. Boyd worked in the Montgomery and Lowndes County School Systems, and Dr. Langham worked in the Elmore County School System.

Dr. Mackey recognized the following attendees: Dr. Kerry Palmer, Dean of Education at Troy University, Dr. Carolyn Corliss, Dean of Education at Huntingdon College, and Dr. Kellie Shumack, Associate Dean of Education at Auburn University in Montgomery.

There being no other business before the Board, on motion by Dr. Wayne Reynolds and seconded by Mrs. Stephanie Bell, Board Members voted unanimously to adjourn the meeting at 10:22 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Tuesday, July 13, 2021, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
