

## <u>MEMORANDUM</u>

**RE:** American Rescue Plan (ARP) Homeless II Funds

The Alabama State Department of Education (ALSDE) was awarded a total of \$13,239,031.00 for ARP Homeless funds. The first disbursement of these funds was provided to qualifying local education agencies (LEAs) with the Fiscal Year (FY) 2021 McKinney-Vento Grant on June 1, 2021, (ARP Homeless I). The second round of these funds will be disbursed on October 1, 2021, (ARP Homeless II). For ARP Homeless II, states may reserve up to 25 percent of their allocation for state uses and must distribute at least 75 percent of their allocation to LEAs via a formula that uses the LEA's allocation under Title I, Part A, of the *Elementary Secondary Education Act* (ESEA) and the number of identified homeless children and youth in either school year 2018-2019 or 2019-2020, whichever number is greater.

The LEAs had the option to opt-in or opt-out of ARP Homeless II funds and LEAs with less than an allocated amount of \$5,000 had the option to go into a consortium with another LEA. The LEAs who selected to opt-out of ARP Homeless II will still be provided services through the ARP-Homeless Children and Youth (ARP-HCY) Reservation for State-Level Activities. The ALSDE has produced a new allocation amount for LEAs wanting to opt-in for ARP Homeless II funds. LEAs will receive these funds starting FY 2022 (October 1, 2021). ARP Homeless II funds will be available until September 30, 2024.

The LEAs receiving ARP Homeless II funds will complete an ARP II Homeless Application in eGap with the allocated amount of funds awarded in the attachment. The plan, budget, and budget details will be reviewed, and funds will be released based on the same format utilized for the ARP Homeless I Application.
