RESOLUTION TO ADOPT THE TEACHER OBSERVATION PROGRAM FOR ALABAMA'S TEACHERS

- **WHEREAS,** the Alabama State Board of Education, 1988, adopted a resolution requiring the evaluation of all professional public education personnel; and
- **WHEREAS**, the State Legislature enacted legislation endowing the Alabama State Board of Education with the full force of the law regarding personnel evaluation; and
- **WHEREAS**, the Alabama Teacher Observation Program (ATOP) was developed to address the above enactments; and
- **WHEREAS**, the Alabama State Board of Education adopted the Alabama Core Teaching Standards in 2021; and

WHEREAS, as a result of the adoption of these standards and the *Every Student Succeeds Act* (ESSA) 2016 requirements, a subsequent revision of the EDUCATEAlabama was directed; and

WHEREAS, a representative committee of all stakeholder groups was formed to conduct the revision based on the Alabama Core Teaching Standards and ESSA requirements:

NOW, THEREFORE, BE RESOLVED, That the Alabama State Board of Education does accept and adopt the recommendations of the above referenced committee and retires the current EDUCATEAlabama teacher evaluation system and adopts the Alabama Teacher Observation Program to meet the 1998 requirement of personal evaluation.

WHEREAS, each year, millions of students nationwide apply for financial and services and complete the Free Application for Federal Student Aid (FAFSA); and

WHEREAS, an estimated fifty seven percent of high school seniors qualify for a Pell Grant in Alabama. Forty seven percent completed the FAFSA as of June 4, 2021, leveraging an estimated \$58,969,816 in Pell Grant aid across the state of Alabama; and

WHEREAS, Alabama had over 200 host sites, over 50 high schools recognized for 100% of their seniors completing a college application, 75 colleges and universities participated in the Alabama College Application Campaign Fee Waiver Program, and over 70,000 applications were submitted; and

Dr. Eric G. Mackey stated that there was no report necessary for the month of September.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey stated that he wanted to take some time to recognize outstanding students every month throughout the year. He said that last month the Jobs for Alabama Graduates (JAG) program was recognized and earned a national award. Dr. Mackey stated that students' producers are being recognized today. He said a big push from the Governor and Board has been to get more Computer Science into Alabama schools and for students not to learn only the clerical computer skills, but to actually perform the programming. Dr. Mackey stated that the Department has partnered with the Alabama Association of School Boards to provide students' videos that are produced by students and submitted for judging. He said the following winners of those videos are showcased today. First place, South Girard School in the Phenix City School System; Second place, Central High School in the Phenix City School System; Third place, Section High School in the Jackson County School System; Honorable mention, Calera High School in the Shelby County School System.

Dr. Mackey thanked the Board for recognizing a truly outstanding employee who works in the General Counsel Office of the Alabama State Department of Education, Ms. Michelle Wellman. He said Michelle does a marvelous job in the Legal Office making sure that all the legal paperwork flows. Dr. Mackey thanked Ms. Wellman for all she does for the schools in Alabama and the Department.

Dr. Mackey recognized some Colleges of Education representatives in attendance. Dr. Fred Figliano, Department Chair, Department of Teacher Education and Dr. Joseph Johnson, Head of Secondary Education, Troy University in Troy; Dr. Shirley Farrell, Assistant Professor, Coordinator of Gifted Education, Co-Coordinator of Assessment, College of Education, Troy University in Montgomery; Dr. Kathy Wetzel, Associate Dean for Student Services and Certification, The University of Alabama in Tuscaloosa.

Dr. Mackey thanked the Board for adopting the Teacher Observation Program for Alabama Teachers resolution, which is a huge move forward that consist of hundreds of hours of educators working across the state to develop a new updated teacher observation system. He said that principals and assistant principals across the state are training this fall with plans to implement the program in 2022 under the new federal guidelines.

Dr. Mackey stated that the Governor presented her proclamation on Workforce Development Month, and he too is excited to recognize Alabama's Workforce Development Month. He said that over 8,700 Alabama students from 267 different high schools and career technical centers in Grades 10-12 participate in work-based learning job placements, working over 4.4 million hours, earning over \$40.5 million, and impacting Alabama's economy over \$284 million.
