**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

Conecuh County Schools will: (1) review current research, (2) conduct needs assessments through surveys for parents, students, administrators, and teachers, (3) analyze current and relevant data, and (4) follow required guidelines and regulations from agencies and centers.

To ensure that learning gaps are closed, Conecuh County Schools will strive to accommodate all students. Communication will be provided in various ways and all assessments will be conducted either; traditionally, virtually or a blended approach to meet each students' individual needs. Specifically, CCS will assess students' learning and address student learning gaps by; providing summer learning programs for remediation or enrichment, Providing each student with researched-based resources, and providing a well-rounded curriculum that supports the whole child.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Conecuh County Schools will provide services and assistance for the summer and regular school years from July 1, 2020- September 30, 2022, unless additional guidance is received from ALSDE. However, CCS will continue to sustain some services and assistance for long-term use, to mitigate future issues.

**How will the LEA use ESSER funds to promote remote learning?**

Conecuh County Schools will provide technical assistance with distance education through the use of Schoology. In addition, teachers will be hired to provide home instruction for students with Covid complications. Conecuh County Schools will also provide devices to each student, smart buses with Wifi, and hot-spots with data to students in rural areas.

**3. Equitable Services/Assurances**

The two private schools that are geographically located within Conecuh County Schools were provided the opportunity to receive ESSER funds. They were contacted via telephone and certified letter on June 1, 2020 and CCS received intent to participate from one school. During that time, it was determined that the other private has been permanently closed. The Federal Programs Director had a consultation with the Head Master of Sparta Academy, the only other private school in Conecuh County. Funds will be used based on the private school's Needs Assessments. The consultation with Sparta Academy was completed on June 8, 2020. Funds will be used to purchase technological devices, supplies for health and safety, and classroom instructional resources.

**4. Other Assurances and Certifications**

*The LEA Superintendent or his/her authorized representative assures or certifies the following:*

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. In addition, LEAs that accept funds will continue to pay employees and contractors to the greatest extent practicable based on the unique financial circumstances of the LEA.   - (4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;
  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.



**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

**What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?**

Teachers will be provided additional Professional Development to ensure clarity within the Learning Management System. Parents and students will also have the opportunity to receive technological training and guidance, either remotely or in person through social distancing. Students will not only receive developmentally appropriate and equal opportunities, but equitable as well. Conecuh County Schools will make every effort to ensure that all individual students' plans are followed to fidelity by providing home visits, using a translator when needed or providing paper/pencil based instruction if necessary. Every student will be provided opportunities and choices that meet their individual needs.


