#### PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

#### 2. Allowable Service(s) Assurance

## How will the LEA determine the most important educational needs as a result of COVID-19?

We will survey our administrators, teachers and various stakeholders. We will also complete a needs assessment at each school, and summarize the results for a district-wide needs assessment.

# How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

We will use the data gained from mid-year screeners to determine students that were already behind, or students that were atrisk of falling behind. We will look at the fall 2020 screening data and compare it to the mid-year 2019 data to establish gaps. We will also look at retentions during the 2019/2020 schoolyear. We will look at standards that were covered through educational packets instead of face/face instruction. These standards will be used for remediation purposes in the fall to help students.

#### What is the LEA's proposed timeline for providing services and assistance to students and staff?

This will be a fluid situation with the first implementation already under-way. July 2020 - we will implement protocols for proper sanitizing procedures before students return, to include training and securing proper sanitizing chemicals and distributors. Aug - Dec 2020 - Implement remediation/intervention strategles, secure campuses, coordinate with local officials and secure technologies necessary for a digital platform. Jan 2021 and beyond - support the overall learning process and deal with obstacles as they arise. Continue proper education and sanitation as it relates to COVID - 19

#### How will the LEA use ESSER funds to promote remote learning?

We will use these funds to purchase more technology for students to use at home. We will initiate plans to provide wifi services for low income students or students in rural areas that have limited access. We will purchase educational material platforms that are electronically or digitally available. We will provide services and training that is necessary for the implementation of a digital curriculum.

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overal! State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

#### 6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section. (d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.
