PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. How will the LEA determine the most important educational needs as a result of COVID-19?

HCS will establish learning partnerships with administration, teachers, students, and parents to provide academic, transition, social-emotional support to meet individualized needs. Virtual teachers, PPE, instructional materials, sanitation services and supplies has been determined as a need of the HCS as a result of COVID 19.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Data will allow HCS to inform, engage, and create individualized learning paths. Screeners will be used to gather valuable data to provide students with a successful educational journey. Data will be analyzed to identify possible achievement gaps. Students will receive Tier 1, Tier 2, Tier 3, and if needed, Tier 4 instruction. Student progress will be monitored and adjustments to learning plan will be adjusted as needed. Understanding data and sharing it with key players is essential. Data will allow students to take ownership of their own learning by tracking their own progress. Building administrators will use data to make timely and effective decision on moving student performance in the positive direction. Data will assist teachers in guiding instruction, therefore, allowing them teaching essential content. Also, data will provide parents with an understanding of their child's academic progress, as well as the tools to support them in the home environment.

Abbeville Christian Academy was contacted on June 4, 2020. They will utilize funds to provide technology equipment, instructional supplies, and sanitation supplies for the facility. Proposed timeline will begin August 2020 until August 2021. In May 2021, the school decided not to participate. Details on equitable services implementation form.

4. Other Assurances and Certifications

The LEA Superintendent or his/her authorized representative assures or certifies the following:

 - (2) that the control of funds provided to the local educational agency under each program, and title to property acquired with those funds, will be in a public agency and that a public agency will administer those funds and property;
 - (3) that the local educational agency will use fiscal control and fund accounting procedures that will ensure proper disbursement of, and accounting for, Federal funds paid to that agency under each program;
 - (4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;
 - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
 - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
 - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
 - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

The LEA will use data as its driving force to ensure there are no barriers. Board policy 3.44 is in place to prevent barriers. Should any barriers arise with stakeholders it will be handled according to policy.


