#### PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

#### 2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education does not consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

#### How will the LEA determine the most important educational needs as a result of COVID-19?

The Assistant Superintendent over Instruction, Central Office Executive Team, and Instructional Leadership Staff met on a regular basis during school closing to provide guidance to principals and teachers for student instruction. The group continues to meet to determine learning gaps, to explore methods and resources for learning (blended, virtual, software, devices), and to discuss academic levels and results (including reading) from the last semester of the 2019-2020 school year. Summer reading programs are already in place. In addition, the mental and physical health of our students and staff are top priority. Funds are necessary to address the mental health needs in the school district as well as the purchase of PPE, salaries for continuity of services, sanitation supplies, and necessary equipment and furnishings for school facilities.

### How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

The Madison County School System will utilize a variety of formative assessments to determine learning gaps that may have occurred due to the closing of schools this spring. In K-3 the District will use iReady and mClass to assess reading and math. In grades 4-8 the District will use STAR and in high school Scantron Performance Series. The school system uses a tiered intervention plan to address these gaps. The District also utilizes research-based interventions like Fast ForWord, SPIRE, and REWARDS to address the students most at-risk.

#### What is the LEA's proposed timeline for providing services and assistance to students and staff?

The timeline for using the ESSER funds will begin in March 2020 after schools were closed on March 16th and expected to go through September 30, 2022.

#### How will the LEA use ESSER funds to promote remote learning?

The Madison County School District has already committed funds for MiFi(s), software, and devices for families and students all across the district to provide internet access for teaching and learning in a blended or virtual mode. The ESSER funds will also be used as school reopens for devices and other hardware, software, and connectivity to aid instruction and educational interaction.

#### 3. Equitable Services Assurances

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA receiving ESSER funds will provide equitable services to students and teachers in non-public schools

  - (7) that in the case of any project involving construction -

circumstances affecting an assurance in such application.

- (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

#### 6. Section 427 of the General Education Provisions Act Assurances

Programs, devices, and services are provided equally across the Madison County School District. Students in rural areas of the County and/or students that do not have access to internet services have been provided MiFi(s) as well as devices to receive the same curriculum and the same access to instruction. Funds have been obligated to expand the WiFi connectivity at local schools as well as remotely on school buses to ensure that the district provides digital learning platforms for ALL students in Madison County Schools. If issues and / or barriers arise with any program beneficiaries, the School District will address immediately and take action to resolve.
