#### PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

### 2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

### How will the LEA determine the most important educational needs as a result of COVID-19?

After conducting a thorough needs assessment, various team meetings have been conducted across the district including school meetings, community meetings, district meetings, and finally leadership team meetings to prioritize findings from the needs assessment. Our biggest needs relate to the lack of technology needed for blended and virtual instruction. We also have many needs related to providing a safe and secure environment for all students and staff members where we will need to purchase equipment and supplies. We will also need to provide for mental health support and professional development in the areas of health concern and providing effective virtual and blended learning environments.

# How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Upon returning to school in the fall, all students in grades k-12 will be assessed using our i-Ready assessment program. Teams of teachers will analyze that data along with other data gathered to create educational plans for all of our students. Teachers will have collaborative meetings with parents to ensure partnerships with student plans. Teachers will utilize small group instruction and blended learning opportunities to meet the needs of students. Intensive after school interventions will be offered to all students. The district will offer an intense summer school opportunity for students in the summer of 2021.

  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
- (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

Marengo County will use data to conduct an equity gap analysis to be ongoing through the 2020-2021 school year. The gaps in equity will be addressed by the Marengo County School System with strategies to eliminate all barriers that could keep students, teachers, and other program beneficiaries from participating in or having access to the program being offered by the system. All assurances stated on the application will be followed ensuring equitable access and participation for all students, teachers, and other program beneficiaries.
