PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. How will the LEA determine the most important educational needs as a result of COVID-19?

Enterprise City Schools will determine the most important educational needs as a result of COVID-19 by completing district needs assessment, departmental needs assessments, teacher surveys, parent surveys and student surveys. ECS Next Step Committee met to determine beginning of school opening plan, gathering data, next steps and top priorities. Information from these data sources will be analyzed and the best determination will be made based upon the data results. Enterprise City Schools will work with all stakeholders to ensure the educational needs of students are being addressed.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

It is the goal of Enterprise city schools to ensure that every student receives a quality education. Enterprise City Schools will provide opportunities for students to receive extended learning by providing after school tutoring, enrichment camps and summer learning opportunities. In addition, students will be screened and progress monitored throughout the FY 21 & FY 22 academic school years. What is the LEA's proposed timeline for providing services and assistance to students and staff?

How will the LEA use ESSER funds to promote remote learning?

Enterprise City Schools will promote remote learning by providing students with technology devices to use at home to ensure they're able to participate in the virtual experience. All students in grades K-12 will receive a technology device. Students who are virtual will be allowed to check out devices at schools at any time that is convenient for their family. All faculty and staff will receive professional development to assist in the area of teaching and virtual/remote learning environment.

3. Equitable Services Assurances

Enterprise City Schools will ensure that all private schools in our community will be notified and/or invited to participate. Intent letters will be mailed out for their intent to participate. The private school who elects to participate will be invited to a consultation with the district and the Director of Federal Programs. Each private school person of contact will collaborate with Director of Federal Programs throughout the process. The Director of Federal Programs will assist with the completion of their allocable service plan and assist with the understanding of allowable purchases. Private schools equitable services funds will be used to support the same areas as it appears in part three of ECS service plans. Participating private schools will utilize funds for sanitation, cleaning supplies, computer hardware, PPP equipment, and instructional software.

OTHER ASSURANCES AND CERTIFICATIONS**4. Other Assurances and Certifications**

The LEA Superintendent or his/her authorized representative assures or certifies the following:

- The LEA that receives ESSER funds will, to the greatest extent practicable, continue to compensate its employees and contractors during the period of any disruptions or closures related to COVID-19 in compliance with Section 18006 of Division B of the CARES Act. In addition, LEAs that accept funds will continue to pay employees and contractors to the greatest extent practicable based on the unique financial circumstances of the LEA. (b) The general application submitted by a local education agency under subsection (a) shall set forth assurances

(1) that the local educational agency will administer each program by the application in accordance with all applicable statutes, regulations, program plans, and applications;

(2) that the control of funds provided to the local educational agency under each program, and title to property acquired with those funds, will be in a public agency and that a public agency will administer those funds and property;

(3) that the local educational agency will use fiscal control and fund accounting procedures that will ensure proper disbursement of, and accounting for, Federal funds paid to that agency under each program;

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(b) The Secretary shall require each applicant for assistance under an applicable program (other than an individual) to develop and describe in such applicant's application the steps such applicant proposes to take to ensure equitable access to, and equitable participation in, the project or activity to be conducted with such assistance, by addressing the special needs of students, teachers, and other program beneficiaries in order to overcome barriers to equitable participation, including barriers based on gender, race, color, national origin, disability, and age.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.




