**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

**2. Allowable Service(s) Assurance**

*The LEA Superintendent or his/her authorized representative assures or certifies that:*

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education **does not** consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

**How will the LEA determine the most important educational needs as a result of COVID-19?**

GSCC will analyze results of the STAR assessment and i-Ready assessments to determine needs in reading and math. Additionally, the district surveyed parents to gain insight into the effectiveness of remote learning in the spring. Administrators have also worked with teachers to determine the greatest educational needs. Based on our assessments, GSCS has determined that we will need to expend funds for cleaning supplies, devices, virtual school, salary and benefits for virtual school teachers, additional contracted services for cleaning, picnic tables to space out lunch times, shields for desk and allocation to private school.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

GSCC will utilize STAR scores in grades K-8 to identify learning gaps among instructional levels and subject areas for grade level groups and individual students. In grades 9-12, teachers will utilize formative assessments to determine learning gaps. After learning gaps are identified, teachers and additional part-time instructors will address the instructional gaps during core classroom instruction by utilizing small group and one on one instruction. At-risk students will also be provided with additional instruction through "pull out time" and after-school programs.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Supplies started being purchased in June to prepare for upcoming school year and will continue to be purchased throughout the year. Virtual school, PTIs and Ipads will be available in August. Additional sanitizing days will be being when students return in August and will be ongoing throughout the school year. Picnic table supplies were purchased in July and assembly is currently ongoing. All funds will be expended or encumbered by September 2022.

**How will the LEA use ESSER funds to promote remote learning?**

GSCC will use ESSER funds to purchase devices (iPads) for elementary students. Additionally, we have purchased software that is designed to personalize learning in all subject areas for elementary students (Flordia Virtual School software).

The private school will utilize their funds by purchasing teacher computer. A Zoom meeting was conducted with the private school on 6/30/2020 to discuss their allocation amount and how the funds will be used. Teacher computers will be purchased during the summer. All services will be provided by September 2022.

  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.


