PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education does not consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

How will the LEA determine the most important educational needs as a result of COVID-19?

Analysis and evaluation of the district's educational continuity activities from March to May of 2020. Also, analysis of mid-year assessment data of mathematics and reading instruction from January of 2020. We needed cleaning supplies, personal protective equipment, printing and postage for paper learning packets, and summer remediation support, summer remediation included early literacy support for struggling young readers, extended school year for special needs students, and summer school credit recovery for high school students.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Tultion-free credit recovery and community busing for high school summer school students to assist students who ended the year with falling academic grades. Pre-lests in mathematics and reading for all students in August at the start of the 2020-21 school year. Students with significant learning gaps will be assigned to there intervention resources. Teachers in other subjects will be directed to begin the 2020-21 year with a more formal and intensive review of prior content than in prior years.

What is the LEA's proposed timeline for providing services and assistance to students and staff?

High school summer credit recovery: June 8 to June 26, 2020 Elementary K-3 reading tutoring: July 6 to September 30, 2020 Mental health services and support: March 13 to Decamber 30, 2020

All monles will be expended no later than September 30, 2022

How will the LEA use ESSER funds to promote remote learning?

We used funds to purchase paper and postage to create instructional paper packets for families that did not have internet connectivity during the spring quarantine period. This was an especially important need for our K-2 (amilies due to the fact that the district has only provided chromabooks for grades 3 to 12 in prior years. Counselors also provided remote support to students struggling with the social and emotional pressures associated with the quarantine period.

We monived requests from two private schools in our community that regularly ganicipate with us in oligible fund sharing activities: Prince of Peace Catholic School and Hoover Christian School. We will meet with them in June to determine their needs in regard to this program. They are requesting professional development to include month health training, technology hardware and software, and sentizing cleaning services.

All services will be provided no later than September 30, 2022.

4. Other Assurances and Certifications

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

Instructional improvements funded by this source are focused on improving access to remote learning for all K-2 students, providing summer credit recovery at zero cost for high school students, and supporting struggling readers in grades K-3 with free tutoring. All of these things will improve access to resources and overcome barriers for minority learners. If there are any barriers with stakeholders, we will take those seriously and address in a timely manner.
