**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

<b>2. Allowable Service(s) Assurance</b>
<i>The LEA Superintendent or his/her authorized representative assures or certifies that:</i> The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. The United States Department of Education <b>does not</b> consider the following to be an allowable use of ESSER funds, under any part of 18003: 1) subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs or 2) expenditures related to state or local teacher or faculty unions or associations.

<b>How will the LEA determine the most important educational needs as a result of COVID-19?</b>
Jacksonville City Schools used surveys of employees and parents as the basis of the district's needs assessment related to the COVID-19 pandemic. Survey results were closely reviewed by stakeholder teams to identify the school district's most pressing needs and develop plans to address those needs. The stakeholders identified the need for protective cases and bags to take devices home for on line learning, and products to increase sanitation in the schools and on buses to ensure healthy learning conditions for students on campus.

<b>How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?</b>
Students will be assessed upon his/her return to school in August to determine academic proficiency. Students with significant learning gaps will be provided intervention and remedial services as part of the students' regular academic program.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Resources for sanitation of the schools and buses, plexiglass student sneeze barriers, and technology will be appropriated and/or scheduled before school begins. It is expected that all resources will be in place shortly before school begins and early in the 2020-2021 school year. All CARES grant expenditures will take place no later than September 30, 2022.

**How will the LEA use ESSER funds to promote remote learning?**

Jacksonville City Schools will provide cases, bags, and chargers to students to carry and utilize district owned devices home for remote learning.

**4. Other Assurances and Certifications**

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section.

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.
