## PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

## How will the LEA determine the most important educational needs as a result of COVID-19?

Survey instruments sent to parents and teachers to determine how to serve students this Fall. Buses with Wi-Fi will be strategically placed within the City of Pelham for virtual learning capabilities. Will send needs assessments to teachers to determine their instructional needs. Looked at 19-20 mid school year data to determine what students and teachers would need to continue improving teaching and learning remotely. Because Pelham City Schools is requiring students to wear masks, purchase of a student picture ID system will be purchased so all students may be easily identified (for security purposes).

# How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Assessments at the beginning of the school year to determine where students are academically. Kindergarten assessments will look at both social/emotional needs and academic proficiency. For Grades 1-12, will do diagnostics screening in reading and math. Edgenuity has pre-assessments for every unit so we can determine where all students are academically. Before and after school tutoring will be provided to students identified as requiring additional academic assistance.

# What is the LEA's proposed timeline for providing services and assistance to students and staff?

Began sending needs assessments out to parents and teachers on March 16th and sent again in May. Beginning August 10th, teacher training on instructional software and remote teaching strategies. Purchases of PPE, sanitizers, and additional cleaning equipment and supplies began in April and will continue as supplies need replenishing. Deep cleaning completed and air/water purification systems installed prior to staff and students returning to buildings. Funds will be expended by September 30, 2022.

# How will the LEA use ESSER funds to promote remote learning?

Gaps in remote learning during Pandemic - Ex: Edgenuity to identify academic needs, personal Wi-Fi hot spot devices and Chromebooks for students to use at home. Train teachers on instructional software and remote teaching strategies.

- (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities:
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
- (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

Provide Wi-Fi devices, Chromebooks, translators, and case managers for special populations. All special populations (504, ESL, Special Ed) are assigned case managers who work collaboratively with general education teachers, students, and families to ensure instructional needs are met. In addition, instructional specialists work with teachers to design lessons that are equitable and accessible for all learners.
