**How will the LEA determine the most important educational needs as a result of COVID-19?**

For Phenix City Schools Strategic Plan and Continuous Improvement Plan, stakeholder input is gathered by or from an array of surveys and needs assessments including, but not limited to, the following: Homeless Surveys - Pre-pandemic, End of Year Stakeholder Surveys (Strategic Plan) Spring 2019 and 2020, Title I Surveys - Summer 2019 and 2020, EdParks Technology Surveys - Summer 2019 and 2020, Wireless Access Needs Assessment - March 26, 2020, and Remote Learning Plan Stakeholder Surveys - May 15, 2020.

Use a plethora of assessments, data, and metrics. Phenix City Schools will determine the educational needs to address in Covid-19. Benchmark assessments are, but not limited to, as follows: Grades K-3 - Orbits - beginning and end of the year assessments, Grades K-5 - STAR Math and Reading results - Mid Year - Standard Math and Reading results - May 2020, Grades 3-5 - Beacon Math and Reading results - Mid Year, Grades 9-11 - Mode ACT results, Grades 9-12 - College and Career Reading Indicators, Grade 11 - ACT results, Grade 12 - WorkKeys results.

Phenix City Schools will regularly and informally assess students' performance via summer school (Grades 4-12) and summer reading camps (Grades K-3).

Phenix City Schools will track attendance, using the current year's 90.5% average daily attendance as a general benchmark. Tardancy will be closely monitored by an attendance officer and other assigned personnel.

Phenix City Schools will monitor emotional and behavioral status of students through a variety of means, such as, but not limited to: School incident reports, Social tracking of Covid-19, Free and reduced lunch comparisons (year to year) to assist in detecting hunger and other hardships.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

Data and analysis gathered above will determine the learning gaps derived.

During the school closure due to Covid-19 pandemic, Phenix City Schools closely monitored participation in remote learning. Parents of students not participating were contacted in the following order: first non-participation notice - teacher notified/unreached parent, second non-participation notice - counselor notified/unreached parent, third non-participation notice - administrator notified/unreached parent.

Remote Summer School will be provided to students in grades 4-12.

Remote Summer Reading Camps will be offered to select students in grades K-3.

Student Achievement Fact 2020 will be used to determine students in need of academic assistance.

Each school's Multi-Tiered System of Supports (MTSS) will assess students and develop an individual learning plan.

      1. Summer 2019 surveys indicated that 80% of students had the internet.
      2. Spring 2020 surveys indicated that 96% of students had internet services.
      3. Support is available via electronic requests.
