How will the LEA determine the most important educational needs as a result of COVID-19?

Each Spring the Piedmont City Schools Administration and Staff conduct a comprehensive need s assessment. In 2020, it included the educational needs as a result of COVID-19. We utilized te acher, staff, student, parent and stakeholder interviews and surveys, as well as academic data fr om pre and post assessments to determine academic needs. The use of Scantron as a local ass essment was beneficial due to no state assessment being given. We will continue to use local evi

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

The students in K-3 are given a pre and post assessment with the STAR program and K-2 uses DIBELS. Students K-12 use Scantron for assessments. Once the results are available the teachers and learning team created a PLP [Personalized Learning Plan] for each student. Measuring progress as of March 2020 to May was one indicator of the success of virtual learning. We now will assess the needs comparing March 2020 and August to see if there was a

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

## 6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -
