PROGRAMMATIC HISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

2. Allowable Service(s) Assurance

The LEA Superintendent or his/her authorized representative assures or certifies that:

The LEA will use ESSER funds for activities allowable under section 18003(d) of Division B of the CARES Act. How will the LEA determine the most important educational needs as a result of COVID-19?

Upon receiving Information regarding the CARES Act, the school and system leadership met to determine the needs of the system as related to the effects of COVID-19. As a result of these discussion with principals, administrators & stakeholders, the critical needs of Pike Road Schools were categorized into the areas of Technology, Health, Wellness & Remediation. The action plan that followed included preparing for remote learning and teaching first, safety costs to complete school year second, and providing remedial reading instruction to students who missed reading instruction during the spring.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

We used our assessments from before school went virtual, individual student progress during virtual learning, and reassessment on I-Ready to help determine where learning gaps may exist. We are providing a summer reading program for our students identified through our assessments. Through the summer reading remediation program, which resulted from our overall needs assessment, we will help bridge the learning gap for our students, in order to have them better prepared for the upcoming school year.

How will the LEA use ESSER funds to promote remote learning?

Technology was area of need identified through our assessment. Our current technology equipment and network capability was not sufficient to handle the requirements of remote learning, as a result of COVID-19. In order to provide remote teaching and learning, we were forced to upgrade our devices and WiFi capabilities. With the upgraded equipment, our lead learners were/are capable of providing virtual/remote instruction to our students.

- (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
- (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
