The LEA determined the most important needs through needs assessments completed by our faculty, staff and parents. These survey instruments were analyzed and the most important educational needs have been determined to be as follows: cleaning supplies (safeguard chemicals, janitorial equipment); classroom supplies and postage for schools to mail class schedules, midterm reports, report cards, etc as a way of communicating with parents; hands free outdoor dismissal system for our middle school; software and devices to improve learning as infrastructure and hotspots to improve wifi abilities and boost internet connectivity for learning; professional development and stipends for teachers as they learn and implement a new LMS; and temperature klosks for our schools.
