# PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

Surveys regarding district needs for reopening schools. Overall, both groups indicated safety from COVID-19 and receiving instruction as most important. Additionally, Stakeholders identified overriding concerns for the fall including health and safety of students and access to high quality instruction and teachers in the event of online or blended learning.

# How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

Guntersville City Schools will use common assessments such as STAR Math, Amplify, mClass DIBELS and Edgenuity screeners to identify students learning gaps. Master schedule changes, lengthening the school day, and hiring additional intervention teachers will help us support students needs resulting from the disruption in educational services.
