#### AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. A parent survey was conducted regarding learning environments which was critical in developing LEAD Academy's Reopening Road Map. We will expend these funds in alignment with our school district's goals, objectives, and Reopening Road Map while focusing on the remediation and health needs of our students due to the COVID-19 pandemic. The needs from our plan are PPE, custodial supplies, technology, on-site janitors and janitorial services, afterschool tutoring, and an assisting aide. We are also budgeting for indirect cost.

NWEA and STAR Renaissance will be used to assess student learning gaps and remediation/intervention will be provided through Freckle, Dreambox, and Reading Plus.

## How will the LEA use ESSER funds to promote remote learning?

LEAD Academy will use the funds to provide a clean and safe learning environment. We are providing Chromebooks to students to allow them the option of a traditional or virtual school learning environment. Students who enroll in the virtual learning environment who do not have Internet access will receive a Jetpack with unlimited data through Verizon Wireless.

- (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
- (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and smilar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
- (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (d) A general application submitted under this section shall remain in effect for the duration of the program it covers. The

State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

## 6. Section 427 of the General Education Provisions Act Assurances

We are providing Chromebooks to all students, as well as Jetpacks with unlimited data through Verizon Wireless to students who do not have Internet access at home. If any student, teacher, or other school leader has a barrier to overcome because of COVID-19, LEAD Academy will work expediently to address the need. ALL students will have equal access to learning devices and programs.
