**SUBJECT:** Additional Certification and Professional Development for Driver and Traffic Safety

**Education Teachers** 

To assist local education agencies in seeking Driver and Traffic Safety Education (DTSE) teachers, the Alabama State Department of Education (ALSDE) offers the Additional Certification in Driver and Traffic Safety Education.

The Additional Certification in Driver and Traffic Safety Education approach is for an applicant who already holds a valid Alabama Professional Educator Certificate or Professional Leadership Certificate. The individual will need to successfully complete and earn credit for the required ALSDE basic and advanced Driver Education courses. Please be advised that certification through the Additional Teaching Field (CBT) and Preliminary Certificate Through Exception (ADM) approaches are no longer certification options for DTSE. The first summer session will be taught May 23-27 and May 31-June 3, 2022, and the second session will be taught July 11-15 and July 18-22, 2022, at the site indicated in the first column below. Space will be limited.
