State testing data will be used to determine educational achievement gaps. Parent surveys were sent to establish student needs. We utilized additional teachers to help reduce class sizes particularly in Career Tech classes that require physical attendance. We also hire a mental health professional to address the social and mental challenges of the students.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

We will utilize formative assessments and teacher input. We will also utilize teachers, including retired teachers, to provide tutoring for our students to narrow the gaps in achievement. We will employ a mental health coordinator to be a liaison between our at-risk students and staff. The mental health coordinator will provide necessary information to the teachers to help best benefit the student's learning needs.

We started planning and implementation of services Mid March of 2020. These services will continue until September 30, 2022.

We have purchased educational learning management system (software) in order to provide Online course instruction and remedial services. We also purchased computer devices, hotspots, Internet service and support equipment for our student population. We will utilize teachers, including retired teachers, to provide additional help with remote learners during and after the school day as needed.

 - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
 - (7) that in the case of any project involving construction -
 - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
 - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
 - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and


