PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

How will the LEA determine the most important educational needs as a result of COVID-19?

ACCEL Academy will collect student academic data using the NWEA Map Assessment to measure learning gains and declines in ELA and Math. Additionally, students will take socio-emotional assessments to determine students needs aligned to non-cognitive factors. Lastly, the academy will interview families to determine any family basic needs deficiencies.

How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

ACCEL Academy will assess student learning gaps using the NWEA Map Assessment. Students will then be assigned to intervention classes during school and provided after-school and summer intervention/enrichment experiences in-person and virtually to close learning gaps.

ESSER funds will be utilized to support ongoing computer maintenance and IT services related to the use of remote learning devices for students and staff.

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and

(B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.

(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

All grant program-related sessions/activities will be held in Americans with Disabilities Act (ADA) accessible and compliant facilities. As needed, the grant staff will further develop and implement a plan of action that will address the identified special access needs indicated by program registrants that go over and beyond the access provisions of the ADA facilities, themselves. Coordinate and offer cultural sensitivity and ADA training for program staff. Hire, recruit, and involve individuals from racial and ethnic minority groups, multi-lingual individuals, consumers, and individuals with disabilities to plan, implement, and evaluate program services, to the greatest extent possible. Develop or acquire and disseminate culturally relevant and sensitive curriculum and information materials that can be understood and accessible to all potential participants, regardless of their unique challenges or backgrounds.
