#### PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. LEAs will be allowed to expend funds until 9/30/2022. Pre-award costs to the ESSER fund will be allowed for allowable cost incurred on or after March 13, 2020.

#### 2. Allowable Service(s) Assurance

## How will the LEA determine the most important educational needs as a result of COVID-19?

The superintendent and leadership team have determined our districts most pressing needs as it relates to the health and safety of students and staff, in addition to how we will be able to deliver the most effective and appropriate instruction under the current COVID-19 conditions. Additionally, we have surveyed our parents and staff as to their perceptions and concerns regarding starting the 20-21 school year and based on their responses, we have developed a plan around blended and remote learning opportunities for our students. However, those plans are subject to change based on the COVID-19 conditions in our county at the start of school. The most pressing needs identified in our budget are but are not limited to the following: Assistive technology i.e. laptops, chrome books, wifi hot spots and wifi adapters for school buses, Personal Protective Equipment for staff and students, sanitation supplies, transportation cost, software agreements, Protective barriers for the main offices in each school.

### How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?

The Sumter County BOE will use benchmark data from assessment administered across grades K-11prior to the dismissal of school in march and compare that information to data that will be gleaned from administering the i-ready and ACT benchmark assessment to our students. Also, we are planning to offer summer reading interventions to our primary and middle grades prior to the start of school. Additionally, we will be providing additional ACT and ACT Work Keys prep for students in grades 9-12 along with offering after school tutoring for all students.

#### What is the LEA's proposed timeline for providing services and assistance to students and staff?

During This summer and the coming school year PD will be offered to the instructional staff in order to develop effective instructional practices around the concept of remote learning. We will also look to include remote learning days in our instructional calendar each year moving forward. Budgeted amount for professional development regarding providing effective instruction via remote or blended learning; \$20,000.00. The district provided packs for the students continued instructional learning during the beginning of pendemic. All services will end September 30, 2022.

How will the LEA use ESSER funds to promote remote learning?

The Sumter County BOE will use the ESSER funds to promote remote learning by purchasing the necessary equipment i.e. laptops, chrome books, Wifl adapters for school buses, wifi hot spots and digital supplemental resources to support the overall instructional process. Also, funds will be used to purchase a copier to create student learning packs.

3. Equitable Services Assurances

(4) that the local educational agency will make reports to the State agency or board and to the Secretary as may reasonably be necessary to enable the State agency or board and the Secretary to perform their duties and that the local educational agency will maintain such records, including the records required under section 443, and provide access to those records, as the State agency or board or the Secretary deem necessary to perform their duties;

(5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;

(6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;

(7) that in the case of any project involving construction -

(A) the project is not inconsistent with overall State plans for the construction of school facilities, and (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;

(8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and

(9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
(c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

## 6. Section 427 of the General Education Provisions Act Assurances

(a) The purpose of this section is to assist the Department in implementing the Department's mission to ensure equal access to education and to promote educational excellence throughout the Nation, by -

(1) ensuring equal opportunities to participate for all eligible students, teachers, and other program beneficiaries in any project or activity carried out under an applicable program; and

(2) promoting the ability of such students, teachers, and beneficiaries to meet high standards.

(c) The Secretary may establish criteria and provide technical assistance for meeting the requirements of this section. (d) Nothing in this section shall be construed to alter in any way the rights or responsibilities established under the laws cited in section 400(d) of this Act.

What steps does the LEA propose to take to permit students, teachers, and other program beneficiaries to overcome barriers (including barriers based on gender, race, color, national origin, disability, and age) that impede equal access to, or participation in, the program?

The Sumter County BOE is exploring every available option in order to remove any barrier that will hinder equal access to all students. In addition to purchasing of a variety of devices that will promote on-line access; the district is in the process of migrating it's email platform from the basic Alabama Super Computer hosted email platform to the Office 365 email platform. This will allow us to increase the capacity of our teachers and students to communicate and collaborate with each other. Additionally, we will provide email accounts to all of our students. This will give the district the ability to monitor communication between teachers and students as well as student to student communication. Additionally, if barriers are to arise, we will move to resolve the situation as quickly as possible.
