Mr. Jackson and staff gave a brief overview of the programs that are offered at Ed Farm. Each staff explained their roles and what students can accomplish from the programs that are offered. The audience was enlightened with a video of students and staff performing hands on projects. Dr. Mackey provided updates about his visit and experience at Ed Farm. He said that Alabama students are granted great advantages across the state.
