WHEREAS, through effective dyslexia screening, students with dyslexia can be identified as early as kindergarten, long before their learning challenges have resulted in learning disabilities; and

WHEREAS, early identification and intervention will equip many students with dyslexia for success in school and in life; and

WHEREAS, the Alabama State Board of Education has specifically addressed dyslexia within the *Alabama Administrative Code*; and

WHEREAS, the Alabama State Board of Education has committed itself to supporting Alabama schools and teachers with resources, materials, and professional development; and

WHEREAS, the Alabama State Board of Education has committed to the goal that every child will read on grade level:

WHEREAS, on Manufacturing Month, we commit to strengthening and supporting the Alabama manufactures and hardworking manufacturing employees of today as well as the manufacturers and workers of the future; and

WHEREAS, the National School Lunch Week 2022 (#NSLW22) theme is "Peace, Love, and School Lunch," which spotlights the wide variety of flavors, dishes, delivery options, and tastes that can be customized in today's school lunch; and

WHEREAS, research has indicated that students who eat lunch have better attention and memory, and the quality of foods children eat impacts cognition, and poor nutrition is linked with absenteeism, health problems, hunger symptoms, and psychosocial problems; and

WHEREAS, scientifically based food and nutrition information contributes powerful education benefits to all elementary and secondary students; and

Dr. Mackey stated that there was no report necessary for the month of October.

STATE SUPERINTENDENT’S REPORT

Dr. Mackey congratulated the Principals and Assistant Principals of the Year as well as the Alabama History Teacher of the Year.

Dr. Mackey stated that October is Dyslexia Awareness Month. He introduced Sonya Yates, Representative of the Dyslexia Advisory Council. Ms. Yates gave a big thank you for the Governor and the Board listening to their call in 2015. She acknowledged and thanked Representatives Terri Collins and Alan Baker for their support and help to include Dyslexia in a law in Alabama. Ms. Yates stated that the work the Board does impacts the lives of kids. Ms. Yates introduced two parents Ashley McCurdy who was accompanied by three daughters, and Crystal Morrison who was accompanied by one daughter. Both parents shared some input about their children’s Dyslexia journeys. You can view their stories at <https://www.youtube.com/user/aldeptofed/live>. Dr. Mackey invited the guest to remain for portraits after the meeting. He stated that Alabama is on the right track and wants every child reading proficiently. Dr. Mackey credits the work of the teachers and reading coaches. They are the ones who take the recommendations that comes from the Task Force, Alabama Reading Initiative, and others. Dr. Mackey thanked Representatives Collins and Baker for the work they have done. He said the Dyslexia rules that passed in 2015 laid the foundation for the progress completed today.

Dr. Mackey stated that 12th Grade is on the other end of the spectrum. He introduced Dr. Jimmy Hull, Assistant State Superintendent of Career and Technical Education/Workforce Development, and Mr. Craig Collins, Education Administrator. Dr. Hull stated that Career and Technical Education is becoming more important in Alabama. He said the Joint Leadership Development Conference (JLDC) was held last week with nine Career and Technical Education Student Organizations (CTSO) represented and over 5,000 students in two events. Dr. Hull allowed Mr. Collins to give an update on the Jobs for Alabama’s Graduated (JAG) Program. Mr. Collins stated that Alabama has achieved the 5 of 5 standards of JAG. Graduation rate of

JAG participants at 100%; Total Civilian Job Placement and Military Service at 68%; Total in full-time employment at 87%; Total full-time positive outcomes at 68%; and further education rate at 58%. Dr. Mackey stated that the Governor and Board have been very supportive of the JAG Program.
