Dr. Mackey stated that there was no report necessary for the month of February.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey stated that the two Arts students, Maya Yang the 2023 Elementary Best of Show and Skylar Bush the 2023 Secondary Best of Show, were not in attendance due to the fact that they will be honored on March 8, 2023, at the Arts celebration at the Shakespeare Festival. He said the Board Members adopted the resolutions and will have them for Mrs. Stephanie Bell and Mrs. Marie Manning to present to the students at the Arts celebration. Dr. Mackey reminded the Board Members that all of the Arts winners will attend the celebration. Mr. Andy Meadows, Education Specialist II in the Instructional Services Section, has planned a genuinely nice celebration.

Dr. Mackey congratulated Mrs. Rebecca Johnson, Alabama's 2023 School Counselor of the Year at Daphne Elementary School in the Baldwin County School System. Dr. Mackey acknowledged Mr. Eddie Tyler, Superintendent, and other guest from the Baldwin County School System. Dr. Daniel Birdsong, Assistant Professor of Counseling at the University of Montevallo was also in attendance. Dr. Mackey stated that he had the opportunity to visit Daphne Elementary School in the past and considers it a great school. He invited the honoree and guest to remain for portraits after the meeting.

Dr. Mackey stated that February is Career and Technical Education (CTE) Month. He introduced Dr. Jimmy Hull, Assistant State Superintendent of Career and Technical Education/Workforce Development (WFD). Dr. Hull provided a brief presentation with updates on CTE/WFD that included positive facts. There were 167,405 students enrolled in at least one CTE course in Alabama schools during the 2021-2022 school year. Dr. Hull stated that 586 CTE courses were taken and 79.05% of students were enrolled in CTE during the same school year. Dual enrollment had 510 courses with 31,565 students enrolled. Dr. Hull stated that they see an increase in that number for the 2022-2023 school year. Dr. Hull shared an Alabama CTE program spotlight video series.

There being no other business before the Board, on motion by Mrs. Stephanie Bell and seconded by Dr. Yvette Richardson, Board Members voted unanimously to adjourn the meeting at 10:33 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Thursday, March 9, 2023, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
