Mackey FROM: State Superintendent of Education Jackie Zeigler RE: District I Fiscal Year (FY) 2024 Mental Health Services Coordinator (MHSC) Application In the FY 2024 ETF Budget, Alabama Act 2023-379, the Legislature appropriated \$6,240,000 to provide Tracie West District I funds to local education agencies (LEAs), Charter Schools, and Public Independent Schools to employ President Pro Tem Mental Health Service Coordinators (MHSCs) to support and expand coordination of mental health services throughout their school system. Stephanie Bell Funds are intended to allow LEAs, Charter Schools, and Independent Public Schools to employ a District III coordinator utilizing a minimum salary that would be comparable to social workers or other gualified persons providing mental wellness-related support in other public sectors throughout the state. The LEAs must meet all assurances and guidelines prescribed in the attached application for this funding Yvette M. Richardson, Ed.D. District IV opportunity. The MHSC awards will be approximately \$40,000 and distributed guarterly. LEAs receiving the award will be notified by July 26, 2023, and funds for the position will be available on October 1, 2023. #### 2. ASSURANCES

The LEA Superintendent or his/her authorized representative assures or certifies to:

- 1. Support the position described in this application in compliance with the following local, state, and federal laws, rules, policies, and regulations:

- 2. Use these funds to employ a Mental Health Services Coordinator (MHSC) who meets the qualifications set forth in Alabama Act 2022-442.
- 3. Employ a MHSC that shall, within one year of employment, earn a school-based mental health certificate by successfully completing a certification program developed by the Alabama Department of Mental Health (ADMH).
- 4. On or before the last day of each fiscal year and as requested thereafter, our local board of education shall complete and submit to the ADMH a needs assessment and resource map for the schools under the jurisdiction of the board. The assessment shall document the status of mental health services for the entire school system and allow the local board of education to engage in a quality-improvement process to improve the provision of mental health resources to students within the school system.
- 5. Understand this award shall be subject to annual appropriations made by the Legislature.
- 6. Adopt a local board policy concerning parent opt-in for mental health services as required by Act 2022-442.
- 7. Provide full-time services of an MHSC to the selected LEA that is actively engaged in behavior and foundation wellness activities for students in need of support while working with students, families, school staff/faculty, and community leaders..
- 8. Provide the office, workspace, equipment, and materials as appropriate at the LEA to which the to which the MHSC is assigned.
- 9. Provide access to student records (e.g., assessment data, cumulative records, anecdotal information, and other) that is directly related to academic, behavior, and foundational wellness at the LEA to which the MHSC is assigned.
- 10. Allocate adequate time to support collaboration and training as appropriate for all persons supporting and facilitating the work of the MHSC.
- 11. Authorize and provide adequate funding for travel to support the MHSC's attendance and participation in all professional development provided by the ALSDE and other collaborative partners as it directly relates to the MHSC program (Operation Student Success, Regional MHSC Meetings, MHSC Reflection Summit, etc.)

- 12. Authorize and support the MHSC's development and maintenance of community partnerships that will support behavior and foundational wellness activities of all students.
- 13. Coordinate and facilitate all available local, state, and federal resources that may be utilized to support the MHCS's role in behavior and foundational wellness activities for all students at assigned schools.
- 14. Ensure that no person shall be denied employment, be excluded from participation in, be denied the benefits of, or be subjected to discrimination in any program or activity on the basis of disability, sex, race, national origin, color, or age. Ref: Sec 1983, Civil Rights Act, 42 U.S.C.; Title VI and VII, Civil Rights Act of 1964; Rehabilitation Act Amendment of 1972, Title IX; ADA of 1990; and NCLB Act of 2001.
- 15. Ensure the proposed activity/program budget expenditures are accurate and in keeping with all local, state, and federal laws, rules, policies, and regulations related to the MHSC application.

#### Rationale/Purpose

Our nation's young people are facing an unprecedented mental health crisis. Even before the pandemic, rates of depression, anxiety and suicidal thoughts among youth were on the rise. The pandemic exacerbated those issues disrupting learning, relationships, routines, and increasing isolation—especially among our nation's young people. Alabama Act 2022-442 formally establishes the mental health service coordinator program, provides for the qualifications and duties of the MHSC, and requires each LEA to complete and submit a needs assessment. This position will collaborate with other stakeholders within the LEA and school, in addition to the community, to address obstacles to behavior and foundational wellness through appropriate interventions. For FY 2024, the Alabama Legislature has allocated \$6.2M, which will provide each district with \$40,000 for the employment of an MHSC.

#### Parameters

- All interested LEAs will submit the MHSC application to the ALSDE in keeping with the prescribed guidelines and timelines.
- All MHSCs will serve an LEA that represents an LEA within one (1) Alabama State Board of Education district.
- Budgets should reflect the MHSC's salary, travel, and other expenditures specifically related to the program supported by the MHSC.
- All LEA superintendents/chief school financial officers will be notified by July 26, 2023.

#### Mental Health Service Coordinator Roles and Responsibilities

- Be responsible for coordinating access for student mental health services throughout the local school system.
- Build effective teams by encouraging collaboration among students, teachers, administrators, and other school staff.
- Work toward common goals of equity, access, academic, career, and social/emotional growth.
- Create effective relationships with parents, families, community members, and community agencies.
- Be an active partner in school- and system-level Problem Solving Teams (PSTs).
- Implement behavior and foundational wellness activities as part of the LEA's multi-tier system of support.
- Understand and appreciate the contributions made by others in educating children.
- Build a sense of community, which serves as a platform to create an environment encouraging the success of all students.

#### Developing/Generating/Sustaining Schoolwide Support and Interventions

- Facilitate policies and practices that create and maintain a safe, supportive, and effective learning environment.
- Assist students in making transitions from grade to grade and to postsecondary opportunities.
- Assist with the selection, development, and implementation of individual evidence-based interventions and behavior plans.
- Coordinate mental health invention supports to individuals and small groups.
- Provide professional development and parent education.
- Advocate for the rights of students.
- Team with other school-based mental health professionals and other mental health providers for student services.
- Consult with parents, school staff, administrators, and other stakeholders.
- Provide crisis prevention and intervention.
- Identify, refer to, and utilize community resources.

#### **Providing Direct Service**

- Develop and implement individual, small-group, and whole-school prevention and intervention strategies.
- Incorporate a program to enhance students' foundational wellness skills (e.g., character education, motivation, goal-setting, conflict resolution, suicide and bullying prevention, and resilience).

#### **Developing Family, Community, and Other Relationships**

- Connect students and their families with community organizations, and services.
- Develop and/or support student mentoring programs (e.g., existing school, community, LEA, state, or federal mentoring programs).

#### **Evaluation and Reporting**

- Monitor the progress of individual students and members of various school subgroups.
- Conduct and analyze ongoing formative and summative evaluation data to determine the program's effectiveness.
- Provide and submit reports as requested to the school, LEA central office, and/or ALSDE.

#### QUALIFICATIONS, EXPERIENCES, AND ABILITIES

Alabama Act 2022-442 requires an individual hired as a mental health service coordinator shall possess at least one of the following qualifications:

- 1. Have a bachelor's degree in social work.
- 2. Satisfy ALSDE qualifications for school counselor.
- 3. Satisfy ALSDE qualifications for school nurse.
- 4. Have professional mental health experience or have been licensed in a mental health occupation including, but not limited to, licensure as a licensed professional counselor or marriage and family therapist.
- 5. Other qualifications as determined by the ADMH and the ALSDE.
