APPENDIX

SUMMER MATH CAMPS

These funds are allocated on a per pupil basis, according to the number of students invited to summer math camps in 2023. The amount allocated to each local education agency (LEA) can be found below. Funds will be disbursed prior to the start of the school year, and fund source 1769 should be used to account for the expenditures associated with these funds. All funds should be expended by September 30, 2024.

These funds are allowed to be used as needed by school systems for the following purposes:

1. To pay stipends to general education and/or special education teachers for teaching Grades K-5 students in summer math camp (inclusive of teachers embedding math in reading instruction for Grades K-3).
2. To pay stipends to instructional assistants or paraprofessionals supporting students in Grades K-5 summer math camp.
3. To pay child nutrition staff to support meal preparation for students in Grades K-5 during established hours of the summer math camp.
4. To pay bus drivers and defray associated costs incurred by transporting students in Grades K-5 to and from summer math camp.
5. To purchase instructional equipment, materials, and supplies needed to effectively implement summer math camp for students in Grades K-5.
