RESOLUTION COMMENDING MRS. SERENA OWSLEY ATHENS CITY SCHOOL SYSTEM RECIPIENT OF THE 2023 ROBERT L. MORTON AWARD

RESOLUTION PROCLAIMING SEPTEMBER 2023 AS STATEWIDE ATTENDANCE AWARENESS MONTH IN ALABAMA

- **WHEREAS**, the Alabama State Board of Education and the State Superintendent of Education are committed to dedicating resources and attention to reducing chronic absenteeism rates, starting as early as kindergarten, since good attendance is essential to student achievement and graduation; and
- **WHEREAS**, chronic absence is now a required reporting metric under the federal Every Student Succeeds Act; and
- **WHEREAS**, the Alabama State Department of Education has developed guidelines in support of consistency for school attendance to assist school systems; and
- **WHEREAS**, chronic absence is defined as missing 18 or more days of school for any reason, including excused and unexcused absences, or just two or three days a month, which is a proven predictor of academic trouble and dropout rates; and
- **WHEREAS**, the definition of attendance has expanded "beyond the classroom" to include virtual and remote learning; and
- **WHEREAS,** improving student attendance and reducing chronic absences takes commitment, collaboration, and tailored approaches to challenges and strengths in each community; and
- **WHEREAS,** the impact of chronic absence hits low-income students particularly hard if they do not have the resources to make up for lost time in the classroom, making them more likely to face systemic barriers regarding getting to school; and
- **WHEREAS,** chronic absence exacerbates the achievement gap that separates low income students from their peers; and
- **WHEREAS**, student absenteeism undermines efforts to improve struggling schools since it is hard to measure improvement in classroom instruction if students are not engaged to benefit from instruction; and
- **WHEREAS**, schools and communities must do more to identify, analyze, project, and share data on how many students are chronically absent so that appropriate interventions are matched with the needs of the students; and

WHEREAS, chronic absence can be significantly reduced when school systems, teachers, parents, and communities work together to monitor and promote good attendance and address hurdles that keep children from getting to school:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education does hereby proclaim that Alabama schools will stand with the nation in recognizing September 2023 as "Attendance Awareness Month" and is hereby committed to focusing on reducing chronic absenteeism so that all children have an equitable opportunity to learn, grow, and thrive academically, emotionally, and socially.

RESOLUTION PROCLAIMING OCTOBER 2023 AS STATEWIDE PARENT ENGAGEMENT MONTH IN ALABAMA

WHEREAS, the Alabama State Board of Education and the State Superintendent of Education strongly support parent and family engagement in the education of Alabama students, and parent engagement is critical to student and school success; and

WHEREAS, the Alabama State Board of Education is committed to parent and family engagement in our schools as it strives to provide all public school children with an opportunity for a quality education with high academic standards that offer every student an opportunity to graduate and to obtain the necessary skills to be prepared for the 21st century; and

WHEREAS, more than 30 years of research identify parental engagement as a key component in ensuring a child's academic achievement, and a successful partnership between educators and parents is one of the most crucial factors influencing the success of students in school; and

WHEREAS, Statewide Parent Engagement Month provides parents the opportunity to learn how they can become more actively engaged in their children's education by visiting their children's school, learning about the curriculum, consulting with their children's teachers, and participating in school activities; and

WHEREAS, Statewide Parent Engagement Month is an excellent opportunity for Alabama's public schools to emphasize and increase parent engagement, to partner with communities to raise awareness, and increase support for public education:

NOW, THEREFORE, BE IT RESOLVED, That the Alabama State Board of Education proclaims October 2023 as Statewide Parent Engagement Month in Alabama; declares this year's theme as Home and School Partnerships: Connecting the Dots to Strengthen Student Learning which encourages educators, communities, parents, and families to participate in this observance; and challenges educators to solicit sustained, year-round parent and family engagement.

ALABAMA STATE BOARD OF EDUCATION RESOLUTION ESTABLISHING A CUT SCORE FOR THE LOWEST LEVEL IN READING FOR THE ALABAMA COMPREHENSIVE ASSESSMENT PROGRAM (ACAP)

WHEREAS, the Alabama State Board of Education supports increasing student achievement, including an emphasis on reading in the early grades, as witnessed by its continued commitment to high quality reading instruction, assessment, and professional development; and

WHEREAS, the Alabama Literacy Act specifically provides, in part,

"(h) [As amended by Act 2022-391] Commencing with the 2023-2024 school year, third grade students shall demonstrate sufficient reading skills for promotion to fourth grade. Students shall be provided all of the following options to demonstrate sufficient reading skills for promotion to

fourth grade, and the State Superintendent of Education shall provide guidelines for the implementation of this subsection:

- (1) Scoring above the lowest achievement level, as determined by rule of the State Board of Education, on a board-approved assessment in reading as provided in Section 16-6G-3.
- (2) Earning an acceptable score on an alternative standardized reading assessment as determined and approved by the State Superintendent of Education.
- (3) Demonstrating mastery of third grade minimum essential state reading standards as evidenced by a student reading portfolio. The State Superintendent of Education and the task force established under subsection (a) of Section 16-6G-3 shall establish criteria for minimum essential standards and the student reading portfolios and a definition of what constitutes mastery of all third grade state reading standards.
- (i) If a student does not demonstrate sufficient reading skills on one of the three options listed in subsection (h) and does not qualify for a good cause exemption, the student may not be promoted to fourth grade." Section 16-6G-5, Code of Alabama (1975):
- **NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education establishes that for purposes of promotion to fourth grade under provisions of the *Alabama Literacy Act*, the lowest achievement level for the reading subset of the ACAP English Language Arts will include any and all raw scores below 435; and

BE IT FURTHER RESOLVED, That the Alabama State Board of Education intends to review this lowest achievement level in the summer of 2024 and on a regular basis thereafter, following future administrations of the statewide English Language Arts reading assessment and reserves the right to make amendments as deemed necessary by the Board.

ANNOUNCE INTENT TO REPEAL ALABAMA ADMINISTRATIVE CODE RULE 290-3-3-.60, PERTAINING TO ALTERNATIVE TEACHER PREPARATION ORGANIZATIONS, AND ADOPT NEW ALABAMA ADMINISTRATIVE CODE RULE 290-3-3-.60, PERTAINING TO ALTERNATIVE TEACHER PREPARATION ORGANIZATIONS (ATPO)

ANNOUNCE INTENT TO ADOPT AMENDED ALABAMA ADMINISTRATIVE CODE CHAPTER 290-3-6, PERTAINING TO CHARTER SCHOOLS

EXECUTIVE (INCLUDES LEGAL AND PUBLIC INFORMATION)

Dr. Mackey stated that there was no report necessary for the month of September.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey stated that he became a new superintendent in 2002, his first trip to the Gordon Persons Building was a meeting with Mr. Robert L. Morton, Assistant State Superintendent of Administration and Finance. He recalled a statement from Mr. Morton that "nobody really remembers past superintendents after a few years, but" he added emphatically, "everyone remembers that one who was superintendent when the school system went bankrupt; don't be that one." Dr. Mackey stated that it was a special honor when the Alabama Association of School Business Officials (AASBO) decided to memorialize Mr. Morton by naming their annual award in his honor. Dr. Mackey congratulated Mrs. Serena Owsley, Chief School Financial Officer at Athens City School System, as the 2023 recipient of the Robert L. Morton Award. He acknowledged Mrs. Beth Patton, Superintendent of Athens City School System, and Mr. David Smith, AASBO Executive Director.

Dr. Mackey allowed Dr. Jimmy Hull, Assistant Superintendent of Career and Technical Education (CTE)/Workforce Development, Mr. Craig Collins, Administrator, Jobs for Alabama's Graduates (JAG), Ms. Mandy Nichols and Ms. Charlotte Dabbs, Education Specialists in JAG, to give some highlights and accomplishments of the newly named 6 of 6 Program. The old program was 5 of 5. This year, for the first time, there is an added measure. The JAG Program provides specialized support for students who are up against difficult barriers that limit them from reaching graduation and career goals. Through early intervention including classroom instruction, counseling, employability skills development, and job placements services, the JAG Program has seen a 99% graduation rate and 95% full-time job placement rate. Alabama JAG Performance Goal: Graduation Rate - 99%; Total Civilian Job Placements and Military Service - 74%; Total in Full-Time Employment – 88%; Total in Full-Time Positive Outcomes – 92%; Further Education Rate – 47%; and Connectivity Rate – 97%. Now, teachers contact students after graduation. Everyone finds that as an important piece. Dr. Mackey stated that the Department will ask for an increase of funds for the program next year. He said that growth does not happen without a team, and certainly would not have happened if the Board did not ask for more funding. He thanked the CTE group and the Board Members.

There being no other business before the Board, on motion by Mrs. Marie Manning and seconded by Dr. Tonya Chestnut, Board Members voted unanimously to adjourn the meeting at 10:55 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Thursday, October 12, 2023, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
