  - a. This approach is not available to an individual who holds only a Professional Educator Certificate, Professional Leadership Certificate, Provisional Certificate, Interim Employment Certificate, Business and Industry to Educational Administrator Certificate, Conditional Certificate in a Teaching Field, Higher Education Transitional Certificate, Career and Technical Temporary Certificate, Speech-Language Pathology (Assistant, Temporary, and/or Professional Educator) Certificate, Dyslexia Therapist Endorsement, Child Nutrition Program Director Certificate, Junior Reserve Officer Training Corps (JROTC) Certificate, Early Childhood Development Certificate, Emergency Certificate, Substitute License, Adjunct Instructor Permit, or Computer Science Permit. The occupational proficiency assessment in effect on the date the application is received in the Educator Certification Section must be met.
- 3. The occupational proficiency requirements must be met prior to application submission. If this requirement is not met on the date the application is received in the Educator Certification Section of the ALSDE, the application will be closed, and the individual will be required to reapply with the submission of another application and fee. Individuals who reapply must meet the occupational proficiency requirement in effect on the date the application is received in the Educator Certification Section.
