WHEREAS, providing students the chance to participate in high-quality computer science courses and activities exposes them to the rich opportunities the field offers and provides critical thinking and computational skills that will serve them throughout their lives; and

WHEREAS, all students in Alabama deserve a thorough preparation in computer science education, including access to qualified teachers, technology, and age-appropriate curriculum needed to learn computer science at the elementary and secondary levels of education; and

WHEREAS, participating in an Hour of Code during Computer Science Education Week can serve to demystify the field of computer science and encourage more students to take up further studies of computer science; and

WHEREAS, the field of computer science continues to address equity barriers including attracting more females and underrepresented minorities; and

Dr. Mackey stated that State Superintendent's evaluation was conducted in December as required.

STATE SUPERINTENDENT'S REPORT

Dr. Mackey recognized and congratulated Korri Cunningham from John Herbert Phillips Academy in the Birmingham City School System as the recipient of the 2023 Milken Educator Award. He said that he has never been to a more upbeat and powerful assembly than the one at John Herbert Phillips on October 25, 2023, when Mrs. Cunningham was presented the award. Dr. Mackey stated that it was a testament to Mrs. Cunningham; Dr. Mark Sullivan, Superintendent of Birmingham City School System; Dr. Emeka Nzeocha, Principal of John Herbert Phillips Academy; Mrs. Raynetta K. Wiggins, Assistant Principal of John Herbert Phillips Academy; and Mr. Tristan Cunningham, Husband, who were all in attendance. Dr. Mackey told Mrs. Cunningham that he knows her students loves her because he witnessed their reactions at the assembly.

Dr. Mackey acknowledged Mr. Alan Vance Herron, Superintendent of Lamar County School System; Ms. Tracey Walker, Principal of Vernon Elementary School; Ms. Amanda Rogers and Ms. Sharon Little, Teachers at Vernon Elementary School; and Ms. Shannon Sanford, Reading Specialist at Vernon Elementary School, who were in attendance representing Lamar County School System for being recognized as a *National Elementary and Secondary Education Act* (ESEA) School.
