The Alabama Minimum Specifications for School Buses for 2025 document has been posted to the Alabama State Department of Education (ALSDE) website at <u>www.alabamaachieves.org</u> under Teachers and Administrators/Transportation/Minimum Specifications. Changes to the minimum specifications are noted on the "specifications changes" page at the front of the document. The specifications may be copied, as necessary. Hard copies of the specifications will be provided to all school systems as ALSDE instructors and inspectors visit school systems across the state.

The 2025 minimum specifications are effective and mandatory for all school buses ordered by Alabama school systems beginning April 1, 2024. Buses ordered prior to the effective date of the new specifications may comply with the 2024 specifications. Buses not meeting these requirements will not be certified by the ALSDE and may not be used to transport students; therefore, this document should be forwarded to your system transportation supervisor immediately. You should also ensure that your supervisor, shop foreman, and other appropriate staff are familiar with its contents. These specifications have also been provided to all Alabama school bus dealers.
