RESOLUTION TO AUTHORIZE REVIEW OF AN EDUCATOR PREPARATION PROGRAM Auburn University at Montgomery

- **WHEREAS**, Alabama Administrative Code, Rule No. 290-3-3-.59(4)(b)2, requires that approval by the Alabama State Board of Education shall be secured before a proposal for a new program is reviewed by the Office of Teaching and Leading of the Alabama State Department of Education; and
- **WHEREAS,** the State Superintendent of Education has received from the President of Auburn University at Montgomery a written request to develop a Class A Visual Impairment program; and
- **WHEREAS,** the request lists the specific proposed program for which the Alabama State Board of Education approval is being sought, together with information concerning the factors to be considered in determining the need for the program; and
- WHEREAS, Auburn University at Montgomery would be the only institution in Alabama approved to prepare Visual Impairment teachers since the University of Alabama in Huntsville closed its program; and
- **WHEREAS**, Auburn University at Montgomery has had individuals express an interest in having this program in Alabama; and
- **WHEREAS**, Auburn University at Montgomery personnel wish to provide teachers to help address the acute shortage of certified applicants; and
- **WHEREAS**, Auburn University at Montgomery personnel have been advised that the proposed program may not be implemented prior to Alabama State Board of Education approval, based on documentation of compliance with all applicable standards; and
- **WHEREAS**, the State Superintendent of Education recommends that the program be reviewed by the Office of Teaching and Leading of the Alabama State Department of Education:
- **NOW, THEREFORE, BE IT RESOLVED,** That the Alabama State Board of Education hereby authorizes a review of the following program:

RESOLUTION TO APPROVE EDUCATOR PREPARATION PROGRAMS Huntingdon College

WHEREAS, Alabama Administrative Code, Rule 290-3-3-.59(3), allows a program leading to an Alabama Professional Educator Certificate to be approved through the Continuous Improvement in Educator Preparation (CIEP) program review process; and

WHEREAS, Huntingdon College submitted their Class B programs: Biology (6-12), Collaborative Special Education (K-6), Collaborative Special Education (6-12), Elementary Education (K-6), English Language Arts (6-12), General Social Studies (6-12), History (6-12), Mathematics (6-12), Music-Choral (P-12), Music-Instrumental (P-12), and Physical Education (P-12) for review in 2022 and were granted conditional approval through June 30, 2025; and

WHEREAS, Huntingdon College was required to demonstrate progress toward implementing the requirements of the *Alabama Literacy Act* for approval of the programs in Collaborative Special Education (K-6) and Elementary Education (K-6); and

WHEREAS, Huntingdon College is fully accredited through the Council for the Accreditation of Educator Preparation (CAEP), and has its next accreditation visit in Fall 2029; and

WHEREAS, Huntingdon College submitted a progress report in September 2023 (i.e., revised course syllabi, matrix of program progression, evidence of faculty training in the Science of Reading, evidence of newly adopted textbooks, etc.) detailing their efforts toward meeting the recommendations provided by Barksdale Institute for Science of Literacy; and

WHEREAS, the CIEP program approval review for Huntingdon College constituted of both a document submission and a formal visit to the institution; and

WHEREAS, Huntingdon College documented compliance with all standards for the programs submitted; and

WHEREAS, the Alabama literacy review team examined the evidence presented by Huntingdon College and determined that significant progress has been made toward implementing the recommendations submitted by Barksdale; and

WHEREAS, Huntingdon College is now engaged in a process of continuous improvement:

Dr. Mackey congratulated Mrs. Katie Collins from Bluff Park Elementary School in the Hoover City School System, as the 2025-2026 Alabama Teacher of the Year and Elementary Teacher of the Year; Mr. Aubrey Bennett from George W. Dr. Mackey stated that the Teacher of the Year Celebration was well attended, and everyone had a great time last night.
