Dr. Mackey stated that there was no report necessary for the month of June.

# STATE SUPERINTENDENT'S REPORT

Dr. Mackey mentioned that the turnout for the meeting exceeded his expectations and expressed his pleasure at seeing such a large group in attendance today. Dr. Mackey stated that he wanted to review a few of the items the Board Members approved this morning, noting that the final two are particularly important for Alabama educators. Earlier this year, Governor Kay Ivey announced in her speech that one of her main agenda items would be to pass parental leave for state employees and public education employees. The state legislators passed SB199, and Governor Ivey signed it into law, effective July 1, 2025. Dr. Mackey stated that the Board Members adopted the new *Alabama Administrative Code* rule 290-3-1-.05, Pertaining to Paid Parental Leave as an emergency rule due to the approaching effective date. The emergency rule becomes effective immediately to accommodate the effective date. The announcement of the intent to adopt the rule as a permanent rule will open for a 35-day public comment period. Anyone who wants to

comment should do so during the comment period. Dr. Mackey stated for the record; the Board Members spent a great deal of time in the May Work Session discussing the rules. He said the Department received comments and questions from the Board Members since the May discussions, and the attorneys have been providing answers and will continue to do so throughout this process. Dr. Mackey thanked the Board Members for their work.

Dr. Mackey stated that today has been a day of celebrations. He gave a big thank you and congratulations to all the physical education teachers of the year who were honored today. Melissa Hubauer, Bluff Park Elementary School, Hoover City School System, as the 2024-2025 Alabama Elementary Physical Education Teacher of the Year; Jessica Harbison, Bumpus Middle School, Hoover City School System, as the 2024-2025 Alabama Health Educator of the Year; Justin Kelly, Phillips Academy, Birmingham City School System, as the 2024-2025 Alabama Middle School Physical Education Teacher of the Year; and Brandi Hall, Jasper High School, Jasper City School System, as the 2024-2025 Alabama High School Physical Education Teacher of the Year. Dr. Mackey acknowledged Jonathan Thompson, Health Education, Physical Education, and Adapted Physical Education Specialist in the Instructional Services Section. Dr. Mackey stated that Mr. Thompson had the information ready for the May meeting but was asked to postpone the celebration since May had the Alabama Teacher of the Year, Alternate Teacher of the Year, District Teachers of the Year, Green Ribbon Schools, and Employee of the Quarter. Dr. Mackey stated that the Alabama Association for Health, Physical Education, Recreation, and Dance just completed their 100th anniversary. Dr. Mackey emphasized that building students' bodies is equally important as reading and mathematics. The goal is to get students to build themselves physically, mentally, and emotionally.

Dr. Mackey acknowledged high school students from across the state who attended the meeting in collaboration with representatives from A+ Education Partnership. He extended an invitation to them and the A+ Education Partnership representatives to join the Board Members in the Work Session for brief introductions and to share a bit about themselves.

Dr. Mackey acknowledged college students who are interns of Governor Kay Ivey's office. Students in attendance were from The University of Alabama, Auburn University, Clemson University, Spelman College, Faulkner University, and Ole Miss. He said that Ole Miss is well represented in the Governor's office. Dr. Mackey stated that he was glad to have the Governor's interns in attendance today.

Dr. Mackey congratulated Oxford High School in the Oxford City School System as the 2024-2025 American College Application Campaign School of Excellence. Every year, the ACT Organization recognizes one school in each state that shows outstanding progress in getting students prepared for the ACT and ready for college. The schools are not selected by the Department. ACT Organization goes through their algorithm and selects the school that is the best for that particular year. Dr. Mackey stated that Oxford High School will represent Alabama on the national stage. He gave a big thank you and congratulations to Oxford High School. Dr. Mackey asked all honorees and the high school students to remain for portraits after the meeting.

Dr. Mackey announced that three big numbers will be released publicly in the Work Session today. One is the reading scores. Several local elementary schools in the state jumped ahead to celebrate and highlight their impressive scores. Dr. Mackey stated that it is good to have good news to share. He said they will officially go over statewide and districts' data in the Work Session. Also, graduation as well as college and career readiness rates will be released today.

There being no other business before the Board, on motion by Dr. Allen Long and seconded by Dr. Yvette Richardson, Board Members voted unanimously to adjourn the meeting at 10:16 a.m. The next Alabama State Board of Education Meeting for Elementary and Secondary Education will be held on Tuesday, July 8, 2025, at 10 a.m. in the Auditorium of the Gordon Persons Building followed by the Work Session.
